In addition, the clerk must direct the plaintiff to serve a **Notice Of Registration Of Foreign Child Custody Order** (AOC-CV-661) upon all of the persons listed in Paragraph 3 of this Petition and upon defendant, if different.

IMPORTANT: The Notice Of Registration Of Foreign Child Custody Order will inform the recipient of his or her right to contest the validity of the foreign order. If a timely request for hearing to contest the validity of the foreign order is not filed, the registration is confirmed as a matter of law, and the person requesting registration and all persons served with the Notice of Registration Of Foreign Child Custody Order **MUST BE NOTIFIED BY THE COURT** of the confirmation. Form AOC-CV-664 **Order Confirming Registration Or DenyingConfirmation Or Registration Of Foreign Child Custody Order** is available for a judge to sign.
