ROAD RUNNER CAR RENTAL AGREEMENT
 This agreement is governed and construed in accordance with the laws of Dominica. The LESSEE acknowledges and agrees to the following:

- Only drivers authorized by ROAD RUNNER CO INC are permitted to operate the vehicle. The LESSEE is responsible for all damages to the vehicle during the lease period. When the rental is in the name of a Company only employees of that company who are over the age of 25 with a valid drivers permit for 2 years or more are authorized to drive.
- The LESSEE is fully responsible for the cost of repairing any damage to the vehicle whether or not due to his/her fault unless covered by terms of a Damage Waiver Agreement accepted within this contract.
- The LESSEE agrees that the cost of damage repair can be charged against their credit card and that they are accountable for any damage to the vehicle which may not be visible at the time of vehicle return but that occurred during the lease period. ROAD RUNNER CO. INC shall retain the credit card authorization slip to verify this possibility and effect charges as necessary including charges associated with Clause 4 & 6.
- The LESSEE is responsible for all parking and traffic violations. The LESSEE accepts personal liability and shall pay on demand all parking charges and all traffic fines, charges or other legal fees associated with the operation of the vehicle during the lease period.
- The vehicle shall not be operated (1) to propel or tow any vehicle, trailer or other object (2) to compete in any race, test or contest (3) to transport goods in violation of customs regulations or in any other illegal manner (4) by any person under the influence of alcohol or drugs or (5) in contravention of the Road Traffic Regulations Act.
- The LESSEE shall return the vehicle with same amount of fuel at the time of rental or a refueling charge of US\$10/gallon will apply and shall return the vehicle at the time agreed or extra charges will apply at the rate of US\$10/hour to a maximum equivalent to daily rate. Additional cleaning charges will apply if the vehicle is returned with excess foul odour or dirt/grime/stain damage to the upholstery.
- The LESSEE is obliged to report to ROAD RUNNER CO INC and the police authority any accidents, damages or theft associated with the vehicle immediately. The LESSEE agrees further in the case of an accident (1) to obtain the names and vehicle registration numbers of parties involved (2) not to admit liability or guilt or give money to any parties involved (3) not to abandon the vehicle without adequate provisions for safeguarding an securing same.
- ROAD RUNNER CO INC whilst taking all precautions and using best efforts to prevent such happening, shall not be held liable for any loss or damage arising from any fault or defect in or from mechanical or physical failure of the vehicle. The LESSEE is responsible for reporting to ROAD RUNNER CO. INC any noticeable malfunctioning of vehicle within 24h of the start of the lease period. The LESSEE shall always lock the vehicle when not in use. The LESSOR will not be held liable for any loss of personal property or otherwise.
- The LESSEE is fully responsible for the custody and care of the leased cellular phone and/or car seat(s) when assigned and shall be liable for new replacement value if either/all items are lost, damaged or stolen. Cell Yes No #: _____ \$ _____ Car Seat Yes No Qty: _____
- ROAD RUNNER CO INC reserves the right to without notice repossess the vehicle at any time if conditions of this agreement are not being adhered to and for such purpose may enter upon premises where the vehicle may be and remove the same and the LESSEE shall be responsible for and indemnify ROAD RUNNER CO INC against all actions, claims, costs and damages consequent upon or arising from such repossession or removal.

Coverage also applies in the event of a collision with a non-vehicle or physical property of another, up to US\$25,000 but excludes damage from the rented vehicle to persons and animals.
