You will need to attach a written statement to Your Form 104X.
 Write the following explanation as your reason for amending your Colorado return:
 "The original Colorado return incorrectly had a Refundable Alternative Fuel Vehicle Credit

amount on Form 104(CR), Part II, Line 8. This amended return correctly shows no Refundable Alternative Fuel Vehicle Credit amount on Line 8."
