REPORTING METHODS

- ALIR Transactions** Send state required transactions in a batch mode based on state specified format, frequency and communication method (FTP/SFTP, EDI or by posting to state web site) using IVANS ALIR software.
- ALIR BOB** Book of Business – All ‘in force’ policy/insured/vehicle information sent in a batch mode based on state specified format, frequency and communication method (FTP/SFTP, EDI or by posting to state web site) using IVANS ALIR software.
- OLV** Respond to real time state initiated verifications based on state specifications using the IVANS On-Line Verification (OLV) System along with IVANS ALIR software
- SR22/SR26** The SR22 is a form which must be filed by an insurance company with certain states verifying that certain auto liability insurance coverage is in effect for a particular individual. The SR26 is a form which must be filed by an insurance company with the state notifying that an SR22 form has lapsed or been canceled. These forms are usually required for drivers who have bad driving records including DUI. The SR22/SR26 filing is also called D44/d45 in California. Florida also requires a FR44 form specifically for drivers convicted of DUI. IVANS provides electronic reporting for all of the states requiring electronic SR22/26 reporting in the X12 Format.
