5. Any transactions entered into by a person or firm, acting in reliance on this Certification shall be enforceable against the Trust Assets. The Credit Union may act in reliance upon this Certification and is no liable to any person for so acting. The person executing this Certification of Trust, agrees to indemnify and hold the Credit Union, its directors, officers and employees free and harmless from any and all claims, demands or damages (including reasonable legal and court costs) resulting from its reliance upon this Certification and actions related to the Trust.

6. In order to exercise the signature authority of the Trustee under the Trust, only one signature of the Trustee(s) is required in order to exercise the power and authority of the Trustee. The Declarant, as Trustee, Certifies that he/she may sign as having all powers and authority to act for all phases of the Trust. THE CREDIT UNION WILL NOT ACCEPT, OR AUTHORIZE, THE EXERCISE OF DUAL SIGNATURES IN ORDER TO EFFECT THE POWERS UNDER THE TRUST.
