

AFFIDAVIT OF ARREARS

You have been given an affidavit of arrears, which will be used to determine how much back child support (arrears) is owed to you. An affidavit is a statement made under oath, and will be used in legal proceedings to determine child support. So it is important that you complete it as fully and accurately as possible.

WE CANNOT PROCEED WITH ENFORCEMENT OF YOUR CASE UNTIL WE RECEIVE YOUR COMPLETED AFFIDAVIT OF ARREARS. IF YOU DO NOT RETURN IT TO US YOUR CASE MAY BE CLOSED.

1. Start with the year and month that child support was ordered. If there is a judgment or court ordered arrears, start with the month following the end date of the judgment or arrears.
2. In the Amount Due column include only the amount of the monthly current support that was ordered. **DO NOT** include any amount ordered to be paid on the past arrears.
3. If there was spousal support ordered, this should be included in the Amount Due column.
4. The Amount Paid column should include any money received from the non-custodial parent **for child support or spousal support**. Include any payments made directly to you or any payments made through the Family Support Registry. **DO NOT** include payments not intended as child support or spousal support, such as gifts, payments to maintain property, etc.
5. If you wish to forgive any back child support owed by the custodial parent up to this date, and only want child support from this time forward, you can write "I waive arrears" on the affidavit.
6. Sign the affidavit, have it notarized, and return to the child support enforcement office. You may bring it to the child support enforcement office to have it notarized.
