Summer 2014 Request for Financial Aid

After you have registered for your Summer 2014 classes, complete the shaded area of this form and submit to the FA Office along with a <u>printed</u> Summer 2014 class schedule. Your request may be mailed, scanned/emailed, faxed or dropped off in the FA Office. Incomplete requests will not be processed.

Summer financial aid is calculated separately from fall and spring because of multiple sessions and multiple start/stop dates.

You must submit a **2013-2014 FAFSA** in order to be eligible (the same FAFSA used for fall 2013 and spring 2014). Only unused grant or loan funds for 2013-2014 may be awarded for summer 2014.

A student loan will be offered <u>only</u> if requested. **You** must be enrolled in at least <u>six credits</u> to be eligible for a summer loan (in any combination of sessions) and MPN and EC must be complete. Loans are required to be disbursed in two installments.

Your estimated Summer 2014 financial aid award will be calculated and posted in PeopleSoft Self-Service. If you have no remaining eligibility for summer financial aid, we will attempt to notify you in time to make payment arrangements or drop without penalty.

All summer aid is contingent on meeting SAP (Satisfactory Academic Progress) if you are or have previously been enrolled. End of spring term SAP assessment should be completed by May 23, so your estimated aid may change as a result of spring grades. Students currently on WARNING or PLAN OF ACTION will not be eligible to charge books until end of spring term SAP assessment is completed.

If your summer schedule changes, submit a revised copy of your schedule to the FA Office. Changing your summer schedule may result in less eligibility. Adding a class to your schedule after May 20 will <u>not</u> result in additional financial aid.

The automated SFA Bookstore Charge Period for summer is **May 16 through May 28.** If your class begins prior to May 16, you may request a manual voucher by email to southcentral-financialaid@kctcs.edu when your class begins. If eligible, your voucher should be ready to pick up in the FA Office in 24-48 hours.

Refunds begin June 5. If your class begins after May 19, you should receive a refund two-three weeks after your summer class begins. All loans require two disbursements--the second loan disbursement is scheduled for July 10 (after midpoint of summer term).

Disbursement/refund dates for summer are projected and <u>not</u> guaranteed and depend upon many unforeseen circumstances beyond the control of the Financial Aid Office.
