- Who must complete a Document 1-Continuous Country of Origin Affidavit/Declaration?
  - All sellers (feed yard/auction market/farmer feeder) of fed steers and heifers to National Beef must submit a completed Document 1 – Continuous Country of Origin Affidavit/Declaration to National Beef.
- How often do I need to complete Document 1-Continuous Country of Origin Affidavit/Declaration?
  - This is an evergreen document that will need to be resubmitted if the feed yard/selling organization is sold or acquired by new entity OR if the primary origin of a seller's cattle change from their original declaration.
- When must I submit the Continuous Country of Origin Affidavit/Declaration to National Beef?
  - National Beef <u>must</u> have a signed Continuous Country of Origin Affidavit/Declaration on file at its headquarters at 12200 N. Ambassador Drive, Kansas City, MO 64195 prior to accepting cattle from any supplier. Cattle purchased by National Beef from <u>September 29, 2008 forward</u> must have a seller's signed form on file.

- What other information do I need to provide to National Beef?
  - Seller needs to identify the origin of each specific lot or pen on the seller's show list (example: US or USA). If the lot is a mixed origin lot or pen, seller needs to put all origins of that lot or pen (example: USA/Mexico).
