- 2) In Case of lost passport, present an Affidavit of Loss, Birth Certificate or Marriage Contract and any other documents like Philippine driver license, baptismal certificate, voter's affidavit Profesional Regulatory Commission Card, Etc.

REMINDER

In applying for a new passport in the Philippines, surrender the Travel Document issued by the Philippine Embassy or Consulate together the affidavit of lost of passport (as the case maybe) executed at that Post.

INSTRUCTIONS TO POSTS

- 1) Confirm identity of person applying for a travel document.
- 2) Minor Travel Document Issued.
- 3) Send monthly reports of its issuance to the Department, together with duplicate copy of the travel document.
