As the Chief Deputy Director of the California Employment Development Department (EDD), I am pleased to tell you about the wide variety of services and programs that the EDD provides to California employers and their employees.

WORKFORCE SERVICES: When you are ready to hire new employees, start with the EDD's CalJOBSSM, California's Internet-based labor exchange system. Post your job openings, use the 24 hour virtual recruiter to find qualified candidates, and access training classes and education programs at no cost. Visit CalJOBSSM at www.caljobs.ca.gov 24 hours a day from any location with Internet access. The EDD Workforce Services Branch also provides re-employment services to displaced workers and can quickly conduct focused recruitment campaigns for businesses with specialized needs. In partnership with Employer Advisory Councils, we offer informational seminars that will keep you current on employment-related laws and regulations.

UNEMPLOYMENT INSURANCE: What happens when a former employee files for Unemployment Insurance (UI) benefits? The EDD will notify you when the claim is filed or paid. Please review the notices carefully and respond in a timely manner to wage information requests and to submit eligibility information about an employee who quits, has been discharged, is unavailable for work, or has refused an offer of suitable employment. Your timely response will help protect your UI reserve account.

state Disability Insurance (SDI) is a partial, short-term wage replacement insurance plan for California workers. It is state-mandated and funded entirely through employee payroll deductions. The SDI program provides two separate benefit programs: Disability Insurance (DI) and Paid Family Leave (PFL). The DI component is available for employees who suffer a loss of wages when they are unable to work due to a non-work-related illness or injury, pregnancy, and childbirth. The PFL component provides benefits to employees who take time off work to care for a seriously ill family member or to bond with a new child. For those employers or employees not required to contribute to SDI, the EDD offers an optional Disability Insurance Elective Coverage (DIEC) program that can protect you as a self-employed individual or as an employer against partial loss of profits and is funded through quarterly premiums. Individuals covered by DIEC are also covered for both DI and PFL programs.

In addition, employers are encouraged to use SDI Online. Did you know that employers are legally required to submit a response to the EDD within two days of receiving a notice that their employee has filed for DI or PFL? SDI Online is the best method to meet the required response time because employers will receive electronic notification that their employee has filed an SDI claim and are able to respond quicker online. WORKFORCE INVESTMENT ACT: The federal Workforce Investment Act (WIA) program offers a comprehensive range of workforce development activities through organizations located in America's Job Center of CaliforniaSM. Available workforce development activities provided in local communities can benefit job seekers, laid-off workers, youth, incumbent workers, new entrants to the workforce, veterans, persons with disabilities, and employers. TAX BRANCH: The EDD's Tax Branch administers the accounting, auditing, and collection functions of California's payroll tax program. We provide a myriad of tools and resources to assist you in meeting your California payroll tax responsibilities. Looking for information about payroll taxes? The EDD website is a great resource.
