INDEX TO PARENTING PLAN MATERIALS

This brochure describes the parenting plan materials. It includes a basic introduction to parenting plans, a list of safety screening questions, and a list of other materials available on the Oregon Judicial Department's family law website.

COVER PAGE

WHAT IS A PARENTING PLAN?

This page gives a basic introduction to the concept of a parenting plan. It gives parents links to several resources to help them write their parenting plan. It includes safety screening questions to help a parent decide whether to use the basic parenting plan or the safety-focused parenting plan.

HOW DO I GET STARTED?

This section lists questions for parents to ask themselves so they may write a parenting plan that fits their own family's needs. It will help guide them through the parenting plan form.

BASIC PARENTING PLAN FORM

This is the basic parenting plan form with check boxes and simple choices. It offers opportunities throughout to help a parent write a plan that fits his or her family's needs. The form may be filled in on-line, saved, changed, emailed, or printed. A parent may print the blank form and fill it in by hand.

BASIC PARENTING PLAN WORKSHEET

This is the same basic parenting plan form with detailed instructions.

ADDITIONAL PAGES TO BASIC FORM

These attachments give parents additional choices for writing a parenting plan to meet their family's needs.

Attachment 3(c) offers a place for parents to set out a different parenting time schedule for a child whose needs are different from the other child's needs, or to include a different schedule for later, when the child's needs have changed because they are older.

Attachment 4.2 offers a place to add additional holidays or other days that may be special to a family.

Attachment 9.5 offers a place to add more paragraphs to the parenting plan.

SAMPLE SCHEDULES (BIRTH TO 36 MONTHS, THREE TO FIVE YEARS, SIX TO TWELVE YEARS, THIRTEEN TO 18 YEARS)

These are sample schedules for each age group. They provide developmental information and help guide a parent through an age-appropriate parenting time schedule. They offer at least one suggestion (sometimes more) for three different levels of parental involvement.

SOURCES USED FOR SAMPLE SCHEDULES

These sources provide references to some of the materials that were used to create the sample schedules.

BLANK CALENDAR

Parents can use the blank calendar to work out an ongoing schedule or to create a schedule for a particular month. The calendar may be filled in on line, saved, changed, emailed, or printed.

LONG DISTANCE PARENTING PLAN FORM

This form is specially designed for parents who live more than 60 miles away from each other. It is a master form with check boxes and simple choices. It offers opportunities throughout to help a parent write a plan that fits his or her family's needs.

It can be filled in on line, saved, changed, emailed or printed. A parent may print the blank form and fill it in by hand.

ATTACHMENTS TO LONG DISTANCE FORM

Attachment 4(a) is a medium distance schedule designed for parents who live 60 to 180 miles apart.

Attachment 4(b) is a long distance Schedule designed for parents who live more than 180 miles apart.

LONG DISTANCE PARENTING PLAN WORKSHEET

This is the same master form with detailed instructions.

WORDS I NEED TO KNOW

This is a list of words and terms that are used in the Parenting Plan Guide or that parents may hear in court or during the legal process.

WHERE CAN I LEARN MORE?

This is a list of books, web sites, and other resource materials. Materials for children are sorted by age group. Materials for adults are sorted by topic. Some listings also include a brief summary of the material.

FEEDBACK FORMS

Parents may fill out an on-line survey or print and fill in a form to give feedback on the parenting plan materials. This will help to improve this website and make it work better for parents.

Safety Focused Parenting Plan

Do you need a Safety Focused Plan? This list can help you decide.

Has the other parent:

- < acted as though violent behavior toward you or your child(ren) is OK in some situations?
- < damaged or destroyed property or pets during an argument?
- < threatened to commit suicide?
- < pushed, slapped, kicked, punched or physically hurt you or your child(ren)?
- < had problems with alcohol or other drugs?
- < needed medication to be safe around others?
- < threatened not to return or not returned your child(ren)?
- <used weapons to threaten or hurt people?
- < threatened to kill you, your child(ren) or anyone else?
- < sexually abused anyone by force, threat of force, or intimidation?
- < been served a protection or no contact order?
- < been arrested for harming or threatening to harm you or anyone else?

If you answered yes to any of these questions, please continue to take your safety, and your children's safety, seriously. You may need to use a Safety Focused Parenting Plan.

CONGRATULATIONS YOU HAVE A PARENTING TIME AGREEMENT!

By signing your parenting time agreement you are making a commitment to follow it.

You may be wondering what to do next. Here are some options:

- You can keep your agreement just between you and the other parent as a way to show your commitment to your children.
- You can give a copy of your signed agreement to the Division of Child Support for filing with your child support order.
- You can take steps to make your parenting plan enforceable by filing a copy of the agreement with your local court.

Remember, a court can force a parent to obey a written agreement **only** if it is an order signed by a judge in a court case. If you want to make your parenting plan into a court order, you need to file the agreement with the court.

If you do not have an open custody or divorce case with the court, you will need to open a court case in order to get your agreement made into an order.

You may want to think about hiring an attorney. It is always a good idea to consult with an attorney and get legal advice before you file a court case. Attorneys can also review your court documents if you decide to file on your own.

If you do not have an attorney, you may want to contact a court facilitator in the family law department. Court facilitators may be able to review your court documents for completeness. Court facilitators **cannot** give legal advice.

If you already have an open custody or divorce case with the court, you can make your agreement into an order by:

- Taking a copy of the signed agreement to an attorney if you have one, or
- Attaching a signed copy of your agreement to court filing documents for filing a judgment in your case, or
- Bringing a copy of your signed agreement to your next hearing and asking the judge to include it in the court order that closes your case.
