AGREED ORDER OF VOLUNTARY SURRENDER

IT IS HEREBY STIPULATED AND AGREED by and between the Kansas Dental Board (the "Board") and David G. Hall, D.D.S. (the "Respondent") as follows:

- 1. The Board is represented herein by its attorney, Randall J. Forbes of Frieden, Unrein & Forbes, LLP, 555 South Kansas Avenue, Suite 303, Topeka, Kansas 66603. The Respondent is represented herein by his attorney, Lisa McPherson of Martin, Pringle, Oliver, Wallace & Bauer, L.L.P., 100 N. Broadway, Ste. 500, Wichita, Kansas 67202.
- 2. The Board is the Kansas agency vested with the authority, pursuant to K.S.A. 74-1404 and K.S.A. 74-1406, to carry out and enforce the provisions of the Kansas Dental Law, K.S.A. 65-1401 *et seq.*, including conducting hearings and proceedings to revoke, suspend or otherwise discipline a Kansas license to practice dentistry.
- 3. The Respondent is presently entitled to engage in the practice of dentistry in the State of Kansas by reason of the Board having issued him Kansas license number 6200. At all times relevant hereto, the Respondent has held a current license to engage in the practice of dentistry in the State of Kansas.
- 4. The Board's Investigation Member has determined that there are reasonable grounds to believe that the Respondent has committed an act or acts in violation of the Kansas

Dental Act, K.S.A. 65-1401 et seq., in the manner delineated in the PETITION FOR DISCIPLINARY ACTION, filed with the Board on or about March 7, 2013, a true and correct copy of which is attached hereto as "Exhibit A."

- 5. The Respondent denies any wrongdoing or other conduct violative of the Kansas Dental Act, K.S.A. 65-1401 *et seq.*, with respect to the allegations in the PETITION FOR DISCIPLINARY ACTION. However, due to the uncertainty of an administrative hearing and due to Respondent's strong desire to pursue other endeavors, Respondent and the Board agree that the following disposition is just and appropriate under the circumstances:
- A. VOLUNTARY SURRENDER. Respondent and the Board agree that Respondent will VOLUNTARILY SURRENDER his license to practice dentistry in the State of Kansas, effective as of the day this Agreed Order of Voluntary Surrender is approved, accepted and made an order of the Board by way of signature of the Board's President or the President's authorized representative.
- B. OTHER REQUIREMENTS. Respondent acknowledges and agrees that as a condition of this Agreed Order of Voluntary Surrender he must, and the Board further orders the Respondent to: (1) comply fully with this Agreed Order of Voluntary Surrender, and (2) comply with any applicable provisions of the Kansas Dental Act, the Board's rules and regulations, and all state and federal laws relating to Kansas dentists.
- C. REAPPLICATION. In consideration of the Board entering into this Agreed Order of Voluntary Surrender, Respondent agrees that he will not reapply for a license to practice dentistry in the State of Kansas for a period of three (3) years from the effective date of this Agreed Order of Voluntary Surrender. In the event Respondent chooses to reapply for licensure after the expiration of the three (3) year period, the Board shall consider the eight (8)

factors set forth in *Vakas v. Kansas Board of Healing Arts*, 248 Kan. 589, Syl. ¶ 2, 808 P.2d 1355 (1991), and Respondent shall bear the burden of proving to the Board his suitability for relicensure by clear and convincing evidence.

- 6. Respondent agrees that all information in the possession of the Board's Investigation Member, its staff, its investigators and its attorney regarding the complaint which led to the initiation of a disciplinary action, the investigation of the complaint and all information discovered during the pendency of the disciplinary action may be disclosed to and considered by the Board as part of the presentation and consideration of the proposal of settlement in the form of this Agreed Order of Voluntary Surrender, with or without the presence of the Respondent or his attorney. In the event that this Agreed Order of Voluntary Surrender is not accepted and approved by the Board, the Respondent further waives any objection to the Board members' consideration of this Agreed Order of Voluntary Surrender or the information mentioned in the preceding sentence and further agrees to waive any claim of due process violation or the right to seek the disqualification of any Board member as a result of the Board member's consideration of said document and information.
- 7. The stipulations and orders contained herein shall not become binding until this Agreed Order of Voluntary Surrender is approved and entered by the Board. The Respondent acknowledges that the approval of the Board's attorney shall not constitute the approval of the Board or bind the Board to approve this Agreed Order of Voluntary Surrender.
- 8. The Respondent agrees that this Agreed Order of Voluntary Surrender is in conformance with Kansas and federal law and the Board has jurisdiction to enter into it. The Respondent further agrees that the Kansas Dental Act, K.S.A. 65-1421 *et seq.*, is constitutional on its face and as applied in this case.

- 9. The contents of this Agreed Order of Voluntary Surrender constitute the entire agreement of the parties and may only be modified by a subsequent writing signed by them. The Agreed Order of Voluntary Surrender shall be interpreted in accordance with the laws of the State of Kansas.
 - 10. The Respondent acknowledges that he has the following rights:
 - A. To have formal notice of charges served upon him;
 - B. To file a response to the charges;
- C. To have notice of and participate in a formal adjudicative hearing with the Board making specific findings of facts and conclusions of law based only upon evidence admitted at such hearing; and
- D. To take advantage of all applicable provisions of the Kansas Administrative Procedures Act and the Act For Judicial Review and Civil Enforcement of Agency Action.

The Respondent freely waives these rights and acknowledges that said waiver is made voluntarily and in consideration of the Board entering into this Agreed Order of Voluntary Surrender. The Respondent further waives the right to seek reconsideration or appeal or otherwise contest this Agreed Order of Voluntary Surrender.

11. The Respondent acknowledges that he enters into this Agreed Order of Voluntary Surrender freely and voluntarily after consultation with counsel of his choosing. The Respondent further acknowledges that he has read this Agreed Order of Voluntary Surrender in its entirety, that he understands its legal consequences and that he agrees that none of its terms are unconscionable, arbitrary or capricious.

- 12. Time is of the essence to this Stipulation and Consent Order. Respondent acknowledges and agrees that any violation of this Agreed Order of Voluntary Surrender shall constitute a willful violation of a lawful Board order and grounds for further disciplinary action against him. The pendency of any disciplinary action arising out of an alleged violation of this Agreed Order of Voluntary Surrender shall not affect the obligation of Respondent to comply with all terms and conditions of this Agreed Order of Voluntary Surrender.
- 13. This Agreed Order of Voluntary Surrender constitutes the entire and final agreement of the parties. In the event any provision of this Agreed Order of Voluntary Surrender is deemed invalid or unenforceable by a court of competent jurisdiction, it shall be severed and the remaining provisions of this Agreed Order of Voluntary Surrender shall be given full force and effect.
- 14. Upon execution by all parties and entry as an order by the Board, this Agreed Order of Voluntary Surrender shall be a public record in the custody of the Board.
- 15. This Agreed Order of Voluntary Surrender shall become effective on the day it is approved, accepted and made an order of the Board by way of signature of the Board's President or the President's authorized representative.
- 16. The Respondent acknowledges that he has been advised by the Board that he would have the right within fifteen (15) days after service of this Agreed Order of Voluntary Surrender to file a petition for reconsideration with the Board and the right within thirty (30) days after service of the Agreed Order of Voluntary Surrender to file a petition for judicial review in the District Court of Shawnee County, Kansas in accordance with the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 et seq., and to serve such a petition for judicial review on the Kansas Dental Board by serving Betty Wright, its

Executive Director, at 900 SW Jackson, Room 564-S, Topeka, KS 66612. The Respondent hereby waives those rights.

PETITION FOR DISCIPLINARY ACTION

The Kansas Dental Board (the "Board") for its petition to revoke, suspend, limit or otherwise discipline the Kansas license of David G. Hall, D.D.S. (the "Licensee") to practice dentistry, alleges and states as follows:

- 1. The Board is the Kansas agency vested with the authority, pursuant to K.S.A. § 74-1404 and K.S.A. § 74-1406, to carry out and enforce the provisions of the Kansas Dental Practices Act, K.S.A. §§ 65-1401 *et seq.*, including conducting hearings and proceedings to revoke, suspend, limit or take other disciplinary action against a Kansas license to practice dentistry.
- 2. The Licensee is presently entitled to engage in the practice of dentistry in the State of Kansas by reason of the Board having issued him Kansas license number 6200. At all times relevant hereto, the Licensee has held a current license to engage in the practice of dentistry in the State of Kansas.
- 3. The Board has received certain information, has investigated and has determined that there are reasonable grounds to believe that the Licensee, while licensed by the Board, has

committed an act or acts in violation of the Kansas Dental Practices Act, K.S.A. §§ 65-1401 et seq.

FACTS COMMON TO CASE NO. 11-84

- 4. In 2010, Licensee submitted to the Board an application for renewal of his Kansas Dental License. As part of that application, Licensee submitted a document signed by him titled Continuing Education Record (the "CE Record") indicating he had taken at least a total of sixty (60) hours of continuing dental education courses during 2009 and 2010. This document also required the Licensee to submit proof of professional liability insurance coverage to the Board.
- 5. K.A.R. § 71-4-1 makes the completion of no less than sixty (60) hours of continuing dental education a condition of license renewal for dentists.
- 6. On March 17, 2011, the Board's Executive Director wrote Licensee requesting documentation to verify that Licensee had attended at least sixty (60) hours of the continuing dental education listed on the CE Record, as well as requesting the Licensee to provide the required proof of professional liability insurance coverage.
- 7. When the Board's Executive Director received no response to the March 17, 2011 request, she again wrote the Licensee on May 19, 2011, requesting documentation to verify that Licensee had attended at least sixty (60) hours of continuing dental education listed on the CE Record, as well as requesting the Licensee to provide the required proof of professional liability insurance coverage.
- 8. The Licensee has never provided to the Board's Executive Director documentation to verify that Licensee had attended at least sixty (60) hours of continuing

dental education listed on the CE Record; nor has Licensee provided the required proof of professional liability insurance coverage.

10. Pursuant to K.S.A. § 65-1436(a)(19), a licensee may be disciplined by the Board if the licensee has "failed to furnish to the board, or its investigators or representatives any information legally requested by the board."

COUNT I

- 11. The Board incorporates the provisions of paragraphs 1 10 herein by reference.
- 12. The Licensee has committed acts that would justify disciplinary action against his license pursuant to K.S.A. § 65-1436 (b) and K.S.A. § 65-1436 (a)(19) in that he has willfully and repeatedly failed to furnish the Board's Executive Director documentation to verify that Licensee had attended at least sixty (60) hours of continuing dental education listed on the CE Record, which information was legally requested by the Board's Executive Director.

COUNT II

- 13. The Board incorporates provisions of paragraphs 1 12 herein by reference.
- 14. The Licensee has committed an act that would justify disciplinary action against his license pursuant to K.S.A. 65-1436 (b) and K.S.A. 65-1436 (a)(1) in that he committed fraud, deceit and misrepresentation in obtaining renewal of his Kansas dental license.

FACTS COMMON TO CASE NO. 12-9

Patient A.C.

15. In February of 2012, the Board received two complaints regarding Licensee's prescription of controlled substances to Patient A.C.

- 16. In addition to being a patient of Licensee's, Patient A.C. was also an employee of Licensee from March 1, 2010 until her death on or about January 22, 2012. Moreover, the complainants referred to Patient A.C. as the "fiancé" of Licensee.
- 17. According to Licensee's records, Licensee started a root canal on Patient A.C.'s tooth #15 on or about August 6, 2011, and a bridge was temporarily cemented on or about September 1, 2011. The bridge was permanently cemented on or about October 8, 2011.
- 18. According to Licensee's records, Licensee prescribed thirty (30) tablets of 300/30 mg of Acetaminophen w/ Codeine to Patient A.C. on or about September 2, 2011 and thirty (30) tablets of 300/30 mg of Acetaminophen w/ Codeine to Patient A.C. on or about October 5, 2011.
- 19. On information and belief, on at least one occasion in December of 2011, Patient A.C. received a Lidocaine injection in her abdominal area from Licensee.
- 20. According to records provided by Walgreens Company, Wal-Mart Pharmacy and Health Information Designs, Inc., from July 19, 2011 through January 10, 2012, Licensee prescribed to Patient A.C., and Patient A.C. subsequently filled Licensee's prescriptions for, the following medications on the following dates:

- A. On or about July 19, 2011, prescribed twenty (20) tablets of Cyclobenzaprine ten (10) milligrams. Filled by Patient A.C. on or about July 19, 2011;
- B. On or about July 19, 2011, prescribed twenty (20) tablets of Cyclobenzaprine ten (10) milligrams. Filled by Patient A.C. on or about July 24, 2011;
- C. On or about July 31, 2011, prescribed one hundred (100) milliliters of Lidocaine, 2%. Filled by Patient A.C. on or about July 31, 2011;

- D. On or about July 31, 2011, prescribed twenty (20) tablets of Cyclobenzaprine ten (10) milligrams. Filled by Patient A.C. on or about July 31, 2011;

- N. On or about November 18, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled by Patient A.C. on or about November 25, 2011;
- O. On or about November 18, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled by Patient A.C. on or about December 3, 2011;
- P. On or about December 7, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled by Patient A.C. on or about December 12, 2011;
- Q. On or about December 7, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled by Patient A.C. on or about December 18, 2011; and
- R. On or about December 27, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled by Patient A.C. on or about December 27, 2011.

- T. On or about December 22, 2011, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled on or about December 22, 2012;

- U. On or about January 2, 2012, prescribed thirty (30) tablets of Acetaminophen w/ Codeine, 300/30 milligrams. Filled on or about January 2, 2012; and
- V. On or about January 10, 2012, prescribed twenty (20) tablets of Cyclobenzaprine, 100 milligrams.
- 21. Patient A.C. was found and pronounced dead on January 22, 2012. According to the autopsy report produced by the Sedgwick County Regional Forensic Science Center, Patient A.C. died as the result of inhalant abuse and Cyclobenzaprine intoxication. Myocarditis was also contributory to her death.
- 22. According to Licensee's records, Licensee did not record any treatment provided to Patient A.C. or medication prescribed to Patient A.C., other than what is listed in Paragraphs 17 and 18 of this Petition.

Patient B.M.

- 23. According to Licensee's records, on or about September 15, 2011, Licensee provided Patient B.M. with composite fillings for tooth #'s 11 and 12.
- 24. According to Licensee's records, on or about September 20, 2011 prescribed thirty (30) tablets of Tramadol 50 milligrams with one (1) refill to Patient B.M. without an appointment.
- 25. According to Licensee's records, on or about November 22, 2011, Licensee placed a temporary crown on Patient B.M.'s tooth # 19 and also prescribed thirty (30) tablets of Tramadol 50 milligrams to Patient B.M.
- 26. According to Licensee's records, on or about December 7, 2011 Licensee prescribed thirty (30) tablets of Tramadol 50 milligrams with one (1) refill to Patient B.M. without an appointment.

- 27. According to Licensee's records, on or about January 4, 2012, Licensee provided Patient B.M. with composite fillings for tooth #'s 8 and 9 and also prescribed thirty (30) tablets of Tramadol 50 milligrams to Patient B.M.
- 28. According to Licensee's records, on or about January 16, 2012, Licensee prescribed thirty (30) tablets of Tramadol 50 milligrams to Patient B.M. without an appointment.
- 29. According to Licensee's records, on or about February 3, 2012, Licensee prescribed thirty (30) tablets of Tramadol 50 milligrams to Patient B.M. without an appointment.
- According to Licensee's records, on or about February 28, 2012, Licensee provided Patient B.M. with one-surface fillings on tooth #'s 20, 21, 22 and 23. Licensee also prescribed thirty (30) tablets of Tramadol 50 milligrams to Patient B.M.
- 31. According to Licensee's records, on or about April 20, 2012, Licensee provided Patient B.M. with multiple fillings and prescribed fifty (50) tablets of Tramadol 50 milligrams to Patient B.M.

Patient J.M.

- 32. According to Licensee's records, Licensee saw Patient J.M. for crown preparation on tooth #18 on or about May 20, 2009, and crown insertion on tooth #3 on or about September 3, 2009.
- 33. According to Licensee's records, subsequent to J.M.'s September 3, 2009 appointment with Licensee, Patient J.M. did not have an appointment with Licensee until November 12, 2011.

34. According to Licensee's records, on or about June 7, 2010, Licensee prescribed forty (40) tablets of Temazepam 15 milligrams with two (2) refills to Patient J.M.; on or about September 21, 2010, Licensee prescribed forty (40) tablets of Temazepam 15 milligrams with two (2) refills to Patient J.M.; and, on or about July 8, 2011, Licensee prescribed forty (40) tablets of Temazepam 15 milligrams with three (3) refills to Patient J.M.

Patient S.F.

- 35. According to Licensee's records, on or about April 7, 2009, a dentist within Licensee's practice noted that pain medication had been denied to Patient S.F., because he was a suspected drug abuser.

104. According to Licensee's records, on or about July 15, 2010, Patient S.K. presented for an emergency exam for tooth #3; however, Patient S.K. did not want to proceed with treatment at that time.

- 105. According to Licensee's records, on or about September 7, 2010, Patient S.K. returned to Licensee's office complaining of swelling and pain. Licensee prescribed twenty (20) tablets of Lortab 5 to Patient S.K.
- 106. According to Licensee's records, on or about November 18, 2010, Licensee prescribed twenty (20) tablets of Lortab 5 to Patient S.K. without an appointment.

- 115. The Licensee has committed an act or acts that would justify disciplinary action against his license pursuant to K.S.A. 65-1436 (b) and K.S.A. 65-1436 (a)(10) in that he has prescribed prescription drugs and/or substances, including controlled substances, in an excessive, improper or inappropriate manner or quantity outside the scope of practice of dentistry and/or in a manner that impairs the health and safety of his patients.

COUNT IV

- 116. The Board incorporates the provisions of paragraphs 1 115 herein by reference.
- 117. The Licensee has committed an act or acts that would justify disciplinary action against his license pursuant to K.S.A. 65-1436(b) and K.S.A. 65-1436(a)(11) in that he has prescribed prescription drugs, including controlled substances, for other than legal and legitimate purposes.

COUNT V

118. The Board incorporates the provisions of paragraphs 1 - 117 herein by reference.

119. The Licensee has committed an act or acts that would justify disciplinary action against his license pursuant to K.S.A. 65-1436(b), K.S.A. 65-1436(a)(17) and K.A.R. 71-1-15 in that he has failed to keep adequate records to indicate or provide a basis for prescribing certain prescription drugs, including controlled substances, to patients.

COUNT VI

- 120. The Board incorporates the provisions of paragraphs 1 119 herein by reference.
- 121. The Licensee has committed acts that would justify disciplinary action against his license pursuant to K.S.A. 65-1436(b) and K.S.A. 65-1436(a)(3) in that he has been determined by the Board to be professionally incompetent as defined in K.S.A. 65-1436(c)(2), for repeated failure to adhere to the standard care applicable to dentists due to the inappropriate, unfounded, undocumented and unwarranted prescription of drugs, including controlled substances, to patients.

COUNT VII

- 122. The Board incorporates the provisions of paragraphs 1 121 herein by reference.
- 123. The Licensee has committed acts that would justify disciplinary action against his license pursuant to K.S.A. 65-1436(b) and K.S.A. 65-1436(a)(4) in that he has committed gross, wanton or willful negligence in the practice of dentistry, by repeatedly and systematically deviating from the applicable standard of care applicable to dentists through the inappropriate, unfounded, undocumented and unwarranted prescription of drugs, including controlled substances, to patients.

WHEREFORE, it is requested that proceedings be initiated pursuant to the Kansas Administrative Procedures Act, K.S.A. 77-501 et seq., and that in accordance therewith findings and conclusions be made that the Licensee has committed acts which justify disciplinary action being taken against his Kansas license to practice dentistry and order such disciplinary action as shall be determined to be appropriate.
