

## Insight Quick Reference | Payroll Accounting System Subject Areas

### What is Payroll Accounting System (PACS)?

- These 25 Subject Areas provide high-level time and attendance data, benefits transactions, and data on other payroll transactions.
- The PACS Subject Areas group the data into HR categories (similar to the PINQ screens in the mainframe).
- PACS data is searchable in *Insight* by either Pay Period Covered or Pay Period Processed.

### History

PACS data dates back to Pay Period 1 of 2013.

### Data Refresh\*

Occurs bi-weekly after BEAR.

\*View the *Insight* Data Refresh Report to determine the most recent date of refresh

### Calendar Filters

- All PACS common reports require the user to select a PAY\_PERIOD\_PROCESSED prompt.
- When building an ad hoc PACS report, users can filter data by Pay Period Processed or Pay Period Covered.
- Pay Period Processed restricts data to show results based on the processed date, whereas Pay Period Covered restricts data based on the effective date of the transaction.

Above Earnings	Employees who exceed the earnings limitation (equivalent to Executive Schedule Level I). This screen displays the time worked (e.g., transaction code, hours, amount, etc.) that was reduced to prevent the employee from exceeding earnings limitations.	61
App Charge	Appropriations Charge. Salary related inquiries.	46
Appointment Limitation	Lump sum payment and appointment limitation inquiries.	48
Charitable Contribution	Charitable contribution related inquiries.	47
Child Support and Alimony	Child support and alimony inquiries.	52
Differential Pay	Salary related inquiries.	46
Earn Leave Detail	Earn leave detail inquiries.	44
Earning Limitation	The total pay for the employee.	45
Financial Allotment	Financial allotment inquiries.	83

TA Miscellaneous	Miscellaneous T&A data and T&A inquiries. Only the data for the original T&A displays during the processing pay period (i.e., when the T&A releases from TIME). Corrected T&A and adjustment data display after PAYE processes.	24
Tax	<b>State Tax:</b> Research State tax inquiries. <b>City Tax:</b> Research City tax inquiries. <b>County Tax:</b> Research County tax inquiries. <b>Federal Tax:</b> Research Federal tax inquiries.	64; 75; 82; 22, 32, 48
Thrift Saving	Thrift Savings Plan (TSP) inquiries.	56
TSP Collection	Automated adjustments to TSP accounts.	62
