Now that the April 15 deadline has past, leaders have time to review responsibilities and procedures where it comes to the IRS and issues pertaining to paid employees. To ease the way, this month's feature article is on the subject, along with links in our Resources section (near the end of this e-letter) to get the information you need.

## STAYING OUT OF TROUBLE WITH THE INTERNAL REVENUE SERVICE (IRS) AND THE STATE TAX COMMISSION

### (Now that tax season is past, leaders can take a look at how payroll taxes are handled)

While not-for-profit organizations may avoid federal income tax, you still have plenty of taxes to pay. In this month's newsletter, we are bringing up some of the tax issues related to your payroll. Check with your tax advisor about these things:

#### 1. Taxes Associated with Paid Employees

If you have at least one employee, you're responsible for payroll taxes:

- Withholding federal (and, where appropriate, state) income taxes
- FICA tax from employees' wages as well as
- The employer share of FICA tax
- Federal and state unemployment taxes.

It is essential that this is done right: your organization will be held responsible, and the fines and penalties for not doing so are severe.

#### 2. Misclassifying Workers

Some bad advice is out there, about just calling your paid employees "independent contractors" so that you don't have to mess with payroll taxes or benefits. An organization's only tax responsibility for an independent contractor is issuing a Form 1099-MISC if payments in the year are \$600 or more, so this SOUNDS good, but may be a very bad idea.

You don't have the freedom to select the label for the worker; classification depends on whether you have sufficient control over the worker. This essentially means having the right to say when, where, and how the work gets done. Having an independent contractor agreement is helpful in showing that you and the worker do not intend any employer-employee relationships, but it doesn't bind the IRS, who is not a party to the agreement. Before you jump to this, consult the IRS and your tax advisor.

#### 3. Expense Accounts

Look at how you pay for travel, entertainment, tools or other business costs for employees. It may be worth setting up an accountable plan. With this arrangement, you deduct the expenses but avoid all payroll taxes on reimbursements, and employees do not have any income from reimbursements.

To be an accountable plan, there must be a formalized arrangement with set, reasonable time frames for action. For example:

- Reimbursable expense must be business related
  - Advances cannot be made before 30 days of expense
  - Employee must turn in receipts within 60 days of expense
  - Employees must return any excess in advances paid within 120 days of the expense
- Consult your accountant/tax advisor to be sure this makes sense for your entity and that is set up correctly.

#### **4. Accurate and Complete Payroll Records**

Not only do you need to maintain payroll records, you need to have them available for IRS inspection. Usually, you keep this information for at least four years, but check to see if there are reasons to keep them longer. Include:

- Time sheets
- Expense accounts
- Copies of W-2's
- Other payroll records
- Forms required by the U.S. Citizenship and Immigration Department, for example:
  - Forms I-9 etc. showing an employee's eligibility to work in the U.S.
  - Any state forms (like E-verify)

#### **5. Monitoring Payroll Service Companies**

Many small nonprofits find it convenient to hire a company to take care of payroll issues. This does not excuse your responsibility to do things right. Proper oversight and monitoring are essential, because if something is wrong, it will come straight back to you. Monitor your tax account to see that funds are being deposited on time and in the correct amount. If deposits are made electronically using [EFTPS.gov](http://EFTPS.gov), you can easily see activities in your account.

#### **6. Pay the IRS first**

Set aside cash for payroll taxes. Amounts withheld from paychecks are considered to be in trust, and not your agency's property. The IRS will not be sympathetic if you can't pay on time.

#### **7. Don't overlook state Unemployment Insurance reporting and payments**

Set aside cash for unemployment insurance contributions or benefit reimbursements. There are penalties for not carrying through with employer responsibilities like filing Utah Form 33H, Employer's Contribution Report, within 30 days following the end of the calendar quarter. Explore the special options available to Section 501(c)(3) nonprofits. See the links in the "Special Resources" section of this e-letter.

### **ANNUAL FILING WITH IRS: THE 990**

Almost all nonprofits—even those without an IRS tax exempt status, and even those that take in very little in donations—must file annually a version of the 990. What's that? How can it be done? Check out the first few entries in our "Resources" section. Then, check the particular rules for your organization about filing a tax return annually. Experts say that there is some confusion out there, especially among small nonprofits that believe they do not have to bother. If in doubt, get some solid advice from your accountant and tax adviser rather than chancing problems down the road.

## **OLDER ADULTS GOING FOR TECHNOLOGY**

Not many years ago, agencies presumed that they needed to communicate with seniors via snail mail, because of resistance to technology and email.

Pew Research Center reports that six in ten seniors now go on line, but there seem to be two distinct groups of senior users. Those seniors who are a little younger, more highly educated, and more affluent tend to have a higher degree of involvement in technology. This group, once engaged, tends to make technology a regular part of their lives. Internet and broadband use is actually higher among this sub-group than in the general population. Of those with college degrees, fully 87% go online and have broadband at home. Use drops off dramatically, however, among those 75 and older. Interestingly, seniors also tend to have more e-readers and fewer smart phones than younger groups, but overall use of electronic devices is steadily increasing.

## **DOMESTIC VIOLENCE SERVICES / CENSUS FOR 2013**

While more than 67,000 victims of domestic violence received assistance from shelters and services across the United States during one 24-hour period in 2013, nearly 10,000 others could not be helped due to a lack of resources, a report from the [National Network to End Domestic Violence](#) finds. Based on a survey of 1,649 domestic violence programs, the report, [Domestic Violence Counts 2013](#) (16 pages, PDF), found that on a single day more than 36,000 adults and children found refuge in emergency shelters and transitional housing, while over 30,000 received counseling, legal advocacy, children's support group services, and other non-residential assistance.

The report also found that 9,641 requests for services went unmet that day, of which 60 percent were requests for housing. But even as demand for their services grows, domestic violence programs are struggling with cuts in funding from government (27 percent), insufficient staffing (20 percent), cuts in funding from private sources (12 percent), and declines in donations from individuals (10 percent). Funded by the [Avon Foundation for Women](#) and [Allstate Foundation](#), the report calls on funders, policy makers, advocates, social service providers, law enforcement officials, courts, and communities to work together to secure additional funding for prevention programs and services for victims of domestic violence.

## **WOMEN IN SCIENCE AND TECHNOLOGY**

Using statistics from France, Germany, Spain, Japan, China, the United Kingdom, and the United States, a new report from the Boston Consulting Group and the L'Oréal Foundation highlights the continuing gender gap in science education and careers for women. While girls perform equally as well as boys in high school science classes in countries with high levels of gender integration, gender stereotypes continue to serve as a deterrent for women interested in a career in science, the report finds.

## **PARTNERSHIP TO RAISE HIGH SCHOOL GRADUATION RATES AND PREPARE STUDENTS FOR COLLEGE**



The [Taco Bell Foundation for Teens](#) and [Boys & Girls Clubs of America](#) have announced A five-year, \$30 million initiative will work to help more than half a million eighth- and ninth-graders help teens graduate from high school career- and college-ready.

To equip eighth- and ninth-graders with the tools and mindset needed to excel in high school and beyond, the initiative will offer access to workshops and coaching programs; an online peer support community; mentoring; opportunities to visit trade schools, colleges, and universities; and career preparation and course planning sessions.

In addition, the two organizations will work to create a college scholarship service that provides teenaged club members with access to \$83 million in scholarship and financial aid opportunities over the next five years.

## WHO GAINED COVERAGE UNDER THE ACA?

New data show strong coverage gains among low- and middle-income adults, as well as young people and minorities during the ACA's initial open enrollment period, according to data from the Urban Institute's Health Reform Monitoring Survey, funded by the Robert Wood Johnson Foundation and the Ford Foundation.

- The number of uninsured adults age 18 to 64 fell by an estimated 5.4 million between September 2013 and early March 2014.
- Most of the gain in coverage was among the low- and middle-income adults targeted by the ACA's Medicaid and Marketplace coverage provisions.
- States that implemented the ACA's Medicaid expansion saw the largest declines in "uninsurance" (rates of uninsured people), driven by gains in coverage among the low-income adults targeted by that expansion.

The Urban Institute Health Policy Center calls this "a promising start". The hope is that as people become insured, health issues will be handled earlier—before they become larger issues, and there will be less reliance on charity care. Another expected effect is that less expensive care will be dispensed in doctors' offices rather than in expensive and over-taxed emergency rooms. If this happens on a larger scale, experts say that the cost of health care for everyone could potentially go down, or at least not increase as rapidly as in the last decade.

## COST OF HEALTH INSURANCE THROUGH EMPLOYERS

According to the **Agency for Healthcare Research and Quality (AHRQ)**:

In 2012, employee contributions toward health insurance premiums averaged \$1,118 for single coverage, \$2,824 for employee-plus-one coverage and \$4,236 for family coverage. Total cost of the premiums averaged, nationwide, \$5,384 for single coverage, \$10,621 for employees plus one, and \$15,473 for family coverage.

LOIs must include most recent IRS tax-exempt status letter and brief history and goals of the applicant organization; description of the program to be funded and the organization's involvement with the issues it seeks to address; a summary of activities for which the organization requests support; an outline of the organization's objectives, anticipated outcomes and implications. Please include the approximate starting date of the program, the duration that the funding will cover, amount of funding needed, other sources of support, and current contact information of the person responsible for communicating with the Foundation. Following Amie's Place Foundation Board review, qualified organizations will be invited to submit a complete application package.

## **DIGITAL PROJECTS FOR THE PUBLIC / NATIONAL ENDOWMENT for the HUMANITIES**

The Digital Projects for the Public program supports projects such as websites, mobile applications, games, and virtual environments that significantly contribute to the public's engagement with humanities ideas. Projects must be analytical and deeply grounded in humanities scholarship in a discipline such as history, religion, anthropology, jurisprudence, or art history. Digital Projects for the Public grants support projects that are largely created for digital platforms. While these projects can take many forms, shapes, and sizes, you should apply to this program primarily to create digital projects or the digital components of a larger project. NEH is a national funding agency, so these projects should demonstrate the potential to attract a broad, general audience. Projects can have



specific targeted audiences (including K-12 students), but they should also strive to cultivate a more inclusive audience.

This round of grants has a total of \$100,000 nationwide.

### **QUICK HEALTH DATA ONLINE: ONLINE TRAINING**

The US Department of Health and Human Services, Office on Women's Health is sponsoring a free, two-part online training for the new Quick Health Data Online. This will greatly facilitate the use of the new resource, so that you can quickly and easily access data needed for a competitive grant application or for needs assessments.

The Quick Health Data Online system contains data on demographics, mortality, reproductive and maternal health, disease incidence, and access to care at the county level for all states and territories; additionally, data are included on prevention, violence, and mental health at the state level. To the extent possible, data are provided by race, ethnicity and gender, and where applicable/available, by age. Also, the system incorporates graphing and mapping features so that the data of interest can be used directly as tables, graphs/chart and maps.

There are two trainings per month. The basic training will provide an overview of the system and the focus on mapping/second training will provide an emphasis on mapping techniques. The trainings are repeated on various days to allow anyone who wishes to participate an opportunity to do so.

Each training will last one hour, and you can be sitting at your desk using your computer. The dates and times available for the sessions are as follows:
