ASSIGNMENT

THIS NON-EXCLUSIVE ASSIGNMENT OF RIGHTS UNDER EASEMENT AGREEMENTS ("Assignment") is made, granted, conveyed and assigned this ____ day of _____, 2011, by and between the COUNTY OF DARE, NORTH CAROLINA, a body politic and corporate, PO Box 1000, Manteo, NC 27954 (the "County") and the TOWN OF NAGS HEAD, NORTH CAROLINA, a North Carolina municipal corporation, PO Box 99, Nags Head, NC 27959 (the "Town").

RECITALS

A. The County previously acquired certain beach nourishment easements from owners of property located in the Town of Nags Head, Dare County. A list of the easements acquired by the County through voluntary conveyance or by condemnation is attached hereto as **Exhibit A**. The easements listed on the attached **Exhibit A** are hereby collectively referred to herein as the "Easements."

B. The Town is in the process of acquiring beach nourishment easements from owners of property located in the Town of Nags Head as part of a beach nourishment project by the Town. The Town has requested the County to assign to the Town non-exclusive rights in and to the Easements to facilitate the Town's beach nourishment project.

C. The County is willing, pursuant to this Assignment, to grant, convey and assign to the Town on a non-exclusive basis (except as otherwise noted herein) and pursuant to the terms and conditions of this Assignment, all of the County's rights and interests retained, granted to and held by the County under and pursuant to the Easements (the "Easement Rights"), with the County also reserving to itself the right to use, on a non-exclusive basis, the County's Easement Rights for the benefit of any current and/or future beach nourishment projects conducted by the County and the County's successors and assigns in title, subject to the terms of this Assignment.

NOW THEREFORE, in consideration of the foregoing recitals, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and received, the County does hereby assign, grant and convey to the Town on a non-exclusive basis (except as set forth herein), all of the County's Easement Rights, subject to the terms and conditions of this Assignment. Upon execution and delivery, this Assignment shall be binding upon the County and the County's respective successors and assigns in interest.

The County hereby reserves to itself the non-exclusive right to use the County's Easement Rights for the benefit of any current and/or future beach nourishment projects conducted by the County and the County's successors and assigns in title, subject to the terms of this Assignment.

With respect to any beach nourishment project conducted by or with the cooperation of the Town, the Town may and is hereby authorized to execute any and all contracts, permits and other instruments as the owner and holder of the Easements.

IN TESTIMONY WHEREOF, the County of Dare has caused this instrument to be executed in its name and behalf by its Chairman, attested by the Clerk to the Board and its seal affixed hereto, all as the act and deed of its Board of Commissioners, pursuant to a resolution adopted on the 18 day of January, 2011, all effective the day and year first above written.

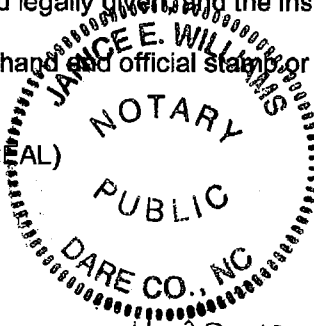
