## INSTRUCTIONS FOR THIRD PARTY PURCHASER INSTALLMENT PAYMENT PLAN CALCULATOR

The EXCEL spreadsheet consists of two tabs labeled "Set Payment" and "Payment Schedule".
Step 1 - in the "Set Payment" spreadsheet the following data entry is necessary (the applicable cells are highlighted):
The amount you paid for the certificate of delinquency in the county clerk's office;
The number of months the installment payment plan will run. (This spreadsheet accommodates up to an 18 month schedule);
The pre-litigation fees added to the total due
The administrative costs added to the total due; and
The amount of interest that has accrued since the certificate of delinquency was purchased.
In the example shown below, the amount paid to the country clerk for the certificate of delinquency was $\$ 1,000.00$. A 12 month installment payment plan has been agreed to. The pre-litigation fee added to the total due is $\$ 175.00$ while the administrative fee is $\$ 115.00$. In the example, assume it has been 10 months since the certificate of delinquency was acquired. Interest in the amount of $\$ 100(\$ 1,000 \times 10 \%)$ has been accrued during this time.

The estimated interest during the term of the installment payment plan is calculated automatically by multiplying the amount paid by $1 \%$ for each month of the installment payment plan - in this case $12 \%$. This is done to keep the computations as simple as possible. The actual interest paid will be lower and this will be reflected in a lower payment in the final month of the plan. The amounts shown for the monthly installment fee, the estimated total that will be paid on the installment plan and the monthly payment amount are all automatically calculated. The total monthly payment in this example is $\$ 128.83$.

Step 2 - go to the "Payment Schedule" tab of the spreadsheet. There you will see a detailed monthly payment schedule for the length of time entered. Amortization schedules are also provided for the "Prior Accrued Interest", the "Pre-litigation and Administrative Fees" and the "Monthly Service Fees". Additionally, a summary of the payments is detailed.

All of the information on this worksheet is based upon the data entered on the "Set Payment" tab of this spreadsheet. No further data entry is needed.
