PRIVACY POLICY—INFORMATION COLLECTED BY THE COURT AND HOW IT IS USED

Except for Internet Protocol addresses, we do not collect any personal information about you through your visit and browsing on this website. We do require personal information if you enter the secure site Internet On-Line Traffic Services page. In order to process any traffic citation transaction you initiate, we will require personal information to process a secure Internet Transaction. Information such as name, mailing address, Date of Birth, Citation number and credit card information may be required to complete the secure transaction. For purposes of this policy, "personal information" is any information that identifies or describes an individual user. When visiting and browsing this website, the following information does not identify an individual user and is not "personal information":

- The domain name used.
- The type of browser and operating system used.
- The date and time you visited this site.
- The web pages or services you accessed at this site.
- If you downloaded a form, the form that was downloaded.

If we collect or store the above electronically collected information it is for the purpose of improving the content of our web services and to help us understand how people are using our website.
