INTRODUCTION

The following information is provided by the Department of Education to serve as a self-evaluation guide for individuals interested in applying for a career and technical education teaching certificate in the State of New Jersey using the alternate route program. The guide provides information about eligible degrees, employment experience, and self-employment experience that can be used to apply for a certificate. It also contains information regarding required state-issued licenses or credentials, when applicable. Note that this guide is not meant to be used to determine actual eligibility to apply, and it does not contain all of the requirements for an actual certificate application. PART A: CAREER AND TECHNICAL EDUCATION CERTIFICATE AND PROGRAM

The holder of a Heating, Ventilation, Air Conditioning and Refrigeration Career and Technical Education Certificate #2517 issued by the New Jersey Department of Education is eligible to teach the following career and technical education program and program of study:

▶ Heating, Ventilation, Air Conditioning and Refrigeration Engineering Technology / Technician, CIP Code # 15.0501: A program that prepares individuals to apply basic engineering principles and technical skills in support of engineers and other professionals engaged in developing and using air conditioning, refrigeration, ventilation, and heating systems. Includes instruction in principles of heating and cooling technology, design and operational testing, inspection and maintenance procedures, installation and operation procedures, and report preparation.

PART B: REQUIRED STATE-ISSUED OCCUPATIONAL LICENSE OR CREDENTIAL

Currently, there are no state-mandated occupational licenses required for this teaching certificate.

PART C: APPLICATION FOR CERTIFICATE USING A DEGREE

Option 1: Bachelor's degree or higher

Applicants using this option must meet <u>all</u> of the following requirements, and should review the requirements prior to submitting an application. The requirements include the following:

Requirements:

1. Applicants must submit an <u>official</u>, <u>sealed copy of their transcript(s)</u> for a bachelor's <u>degree or higher in a Department-approved subject area for the certificate</u>. Applicants must have completed <u>at least 30 credits in a coherent sequence of courses in the subject area</u> from a regionally accredited college or university. Examples of eligible subject areas include the following:

> Mechanical Engineer

The applicant's GPA must be 2.75 or higher. Applicants with a bachelor's degree or higher who graduate on or after September 1, 2004, with a GPA that is below 2.75 in a four-year degree program, but at least 2.50 when a GPA of 4.00 equals an A grade, are eligible to apply for the career and technical education certificate by submitting evidence of a minimum of two years (4,000 hours) of full-time employment or part-time employment or self-employment as per the requirements of **PART D** or **PART E**, below.

Applicants must complete a 24-hour introduction to teaching course through an authorized provider, which serves as an <u>introduction to the teaching profession</u> for those individuals who are exploring career options. Topics include classroom management, lesson planning, introduction to New Jersey core curriculum content standards, and assessment of pupil progress. Option 2: Associate's degree

Applicants using this option must meet <u>all</u> of the following requirements, and should review the requirements prior to submitting an application.

- 1. Applicants must submit an <u>official</u>, <u>sealed copy of their transcript(s)</u> for an <u>associate's degree in a Department-approved subject area for the certificate</u>. Applicants must have completed <u>at least 30 credits in a coherent sequence of courses in the subject area</u> from a regionally accredited college or university:
 - ➤ Heating & Refrigeration & Air Conditioning
 - ➤ Heating & Ventilation & Air Conditioning Design Technology
 - ➤ Air Conditioning & Refrigeration & Heating Technology
- 2. Applicants using a two-year degree must also submit evidence of at least two years (4,000 hours) of employment experience in accordance to the requirements of PART D or PART E, below.
- 3. Applicants must complete a 24-hour introduction to teaching course through an authorized provider, which serves as an <u>introduction to the teaching profession</u> for those individuals who are exploring career options. Topics include classroom management, lesson planning, introduction to New Jersey core curriculum content standards, and assessment of pupil progress. Requirements:

- 1. Applicants must submit evidence of at least <u>four years (equivalent to 8,000 hours) of full-time or part-time employment</u> under any of the job titles listed above.
 - a) The eligible employment experience must be <u>within 10 years</u> of the date of the application submitted to the New Jersey Department of Education. Employment experience that is older than 10 years <u>will not</u> be accepted.
 - b) The eligible employment experience must be <u>documented</u> by the <u>applicant's</u> employer(s) using the Department of Education's Statement of Employment <u>Experience form</u>. If the applicant's eligible employment experience was obtained from more than one employer during the period of time for which eligible hours will be calculated, then a separate Statement of Employment Experience form must be completed by <u>each employer</u>. Employment experience submitted in any other format <u>will not</u> be accepted.  - c) The employer(s) completing a Statement of Employment Experience form(s) will comment on the applicant's work performance and safety practices the <u>following</u> general occupational competencies and tools for this occupation, as follows:

TASKS:

- Maintain current electrician's license or identification card to meet governmental regulations.
- Connect wires to circuit breakers, transformers, or other components.
- Repair or replace wiring, equipment, or fixtures, using hand tools or power tools.
- Assemble, install, test, or maintain electrical or electronic wiring, equipment, appliances, apparatus, or fixtures, using hand tools or power tools.
- > Test electrical systems or continuity of circuits in electrical wiring, equipment, or fixtures, using testing devices, such as ohmmeters, voltmeters, or oscilloscopes, to ensure compatibility and safety of system.
- ➤ Use a variety of tools or equipment, such as power construction equipment, measuring devices, power tools, and testing equipment, such as oscilloscopes, ammeters, or test lamps.
- ➤ Plan layout and installation of electrical wiring, equipment, or fixtures, based on job specifications and local codes.
- Inspect electrical systems, equipment, or components to identify hazards, defects, or the need for adjustment or repair, and to ensure compliance with codes.
- Direct or train workers to install, maintain, or repair electrical wiring, equipment, or fixtures.

PART E: APPLICATION FOR CERTIFICATE USING SELF-EMPLOYMENT EXPERIENCE

Applicants using this option must meet <u>all</u> of the following requirements, and should review the requirements prior to submitting an application.

- 1. Submit evidence of at least 8,000 hours of self-employment under any of the job titles listed under PART D. The self-employment experience must be within 10 years of the date of application to the New Jersey Department of Education for the career and technical education certificate. Self-employment experience that is older than 10 years will not be accepted. Documentation must be submitted as a notarized letter from the applicant's accountant or attorney verifying the applicant's dates of self-employment and verifying that the applicant has filed for state and/or federal taxes using one of the following federal U.S. Census North American Industry Classification Systems (NAICS) or the Standard Industrial Classification (SIC) numbers:
