We support major U.S.-EU energy sector reform ...... There's much to be done on energy efficiency. There's also an enormous amount to be done in the transformation to a clean energy economy.

## Statement of the U.S. - EU Energy Council

U.S. Department of State December 3, 2014

Coordinated action by the EU, the United States and all major and emerging economies will be essential to tackling the threat of global climate change, which remains the defining challenge of our generation. The Council reaffirmed the strong determination of the United States and the EU to work towards the adoption at the United Nations Climate Conference in Paris in 2015 of an ambitious protocol, legal instrument or agreed outcome with legal force, under the Convention and applicable to all parties, which would strengthen the multilateral, rules-based regime. This agreement must be sufficiently ambitious, robust and dynamic in light of the goal to limit global temperature increase to below 2 degrees Celsius . The latest findings of the Intergovernmental Panel on Climate Change serve to emphasize the importance of urgent and effective action.

# Fact Sheet: U.S.-China Joint Announcement on Climate Change and Clean Energy Cooperation

Together, the U.S. and China account for over one third of global greenhouse gas emissions. Today's joint announcement, the culmination of months of bilateral dialogue, highlights the critical role the two countries must play in addressing climate change. The actions they announced are part of the longer range effort to achieve the deep decarbonization of the global economy over time. These actions will also inject momentum into the global climate negotiations on the road to reaching a successful new climate agreement next year in Paris.

EPA Announces First National Regulations to Safeguard Disposal of Coal Ash

The Obama Administration is committed to taking decisive action to combat climate change. Just last month, to drive international discussions leading up to the 2015 climate negotiations in Paris, President Obama made an historic joint announcement with Chinese President Xi Jinping of each country's respective targets for reducing greenhouse gas emissions in the post-2020 period. Building on the United States' bipartisan history of supporting financing for clean energy and climate adaptation in developing countries, the President also announced the United States' \$3 billion commitment to the Green Climate Fund.

### **EPA Adaptation Implementation Plans**

On October 31, 2014, EPA released the final versions of its Agency-wide Climate Change Adaptation Plan (PDF, 64pp, 1.7mb) and the 17 Climate Change Adaptation Implementation Plans produced by the Program and Regional Offices. These final versions were revised from earlier drafts following public comment periods. They respond to directives in Executive Order 13653 -Preparing the United States for the Impacts of Climate Change (PDF, 8pp, 325kb). The final EPA Plan and the 17 Implementation Plans are living documents that will be periodically revised in subsequent years to account for new knowledge, data, scientific evidence, and lessons learned from the Agency's ongoing efforts to integrate climate adaptation planning into its programs, policies, rules and operations.

### FACT SHEET: APEC Leaders Commit to Protect the Environment

With U.S. leadership, the Asia-Pacific Economic Cooperation (APEC) forum plays an important role in pursuing green and sustainable growth in the region. APEC has elevated initiatives and partnerships aimed at promoting environmental protection in a diverse set of areas including: addressing wildlife trafficking and illegal logging; sustainable management of ocean and coastal resources; energy efficiency and infrastructure for electric vehicles; responsible mining practices;

chemical health and safety cooperation; and trade in environmental goods, and aviation emissions.
