### Sign up for Chili Pfest

Entry deadline is **October 18 at 5 p.m.** All teams are required to submit an entry form. Entry fee is \$20 for one **10'x 10' cook-off space** through Oct 11. (\$25 per team thereafter). Additional space may be purchased. Spaces are first come, first served. Entry fee must be received at time of application. ### Team Composition

The head cook from each team will receive a judging turn-in cup at the **cooks' meeting on Saturday, October 20 at 10 a.m.** in the Media Tent. The Head Cook is responsible for the operation of the team space and all actions within or outside of the designated space by members or guests of their cooking team. All Head Cooks must be 18 years of age or older.

### Setup

Cook-off sites are 10'x10'. All equipment and decorations must fit within the site. Additional spaces may be purchased. Cooking teams may set up in designated areas on Main St. between 8 a.m. – 10:30 a.m. on Saturday. All vehicular traffic must vacate Main St. by 10:30 a.m.

### Equipment/Power

No plug-in (110/220 volt) electrical equipment allowed. All electrical equipment must be battery-powered. No generators. Cooking may be done by propane in a self-contained unit (camping stove, grill, etc.) No ground fires. Please monitor the sound levels of audio equipment in respect of your fellow cooks. Repeated violations may result in disqualification.

### Judging

Chili must be submitted for judging at **12:00 p.m. noon on October 20** in the container provided at the head cook meeting. **Late entries will not be accepted. No exceptions.** Judged chili must be prepared on-site. Questions, call 512-990-6116.

**People's choice:** The public will vote for their favorite chili with a ballot system. Each team will receive a zip lock baggie with the team name and number. Ballots for People's Choice award will be weighed. Any team with a foreign object (including but not limited to weights or moistened tickets) inside the zip lock baggie will be immediately disqualified.

### Sampling

Cooks are encouraged to prepare at least 3 gallons of extra chili for sampling by the public. 1 pint is submitted for judging. The more samples you provide the greater potential to win People's Choice Awards. Samples must be ready by 12 noon. **Vendors may only provide samples from noon – 4:00 p.m. Any cook giving out food beyond 4 hours will be required to obtain a food permit from Williamson County.**

### Awards

Awards ceremony at 5 p.m. on the event stage. Prizes for 1<sup>st</sup> – 6<sup>th</sup> place for judged chili & people's choice 1<sup>st</sup> – 3rd place.

### Clean Up

No provision is made by the promoter for disposal of excess chili or food products. Removal is the responsibility of the Head Cook or her/his designee. Site must be cleaned up by **5:30 p.m.** Saturday.

I further agree to indemnify and hold harmless the City of Pflugerville and its governing board, officers, employees, and representatives from liability for the injury or death of any person(s) and damage to property that may result from my negligent or intentional act or omission while participating in the described Pfall Chili Pfest.
