Fee payable in cash (exact change), money order or cashier check only.

United States Trustee quarterly fee. The debtor, or trustee if one is appointed, is required to pay a fee to the United States trustee at the conclusion of each calendar quarter until the case is dismissed or converted to another chapter. The calculation of the amount to be paid is set out in 28 U.S.C. 1930(a)(6).

United States Trustee Requirements:

Copies of all payment advices (pay stubs) or other evidence of payment received by the debtor from any employer within 60 days before the filing of the petition. DO NOT file with the court but provide to the United States Trustee.

Most recent balance sheet, statement of operations, cash-flow statement, and federal income tax return or a statement made under penalty of perjury that none of the above has been prepared or filed. Debtor's federal income tax return (or transcript of return) should be provided for the most recent tax year ending immediately before the commencement of the case and for which a return was filed. DO NOT file with the court but provide to the United States Trustee.

*Items marked with asterisks must be provided with the voluntary petition at the time of filing.
