Re: Resignation from the Commission

Dear Andrew:

It is with real regret that I write to resign as a commissioner for the Mental Health Services Oversight and Accountability Commission. Having the opportunity to serve the commission and the mental health communities of California has been an important experience for me. I enjoyed very productive associations with you, other outstanding commissioners and a very capable staff. I learned from all of you about the challenges facing those suffering from mental illness and the great opportunities we have to stamp out stigma and create cultures of wellness and resilience in California.

I particularly want to thank you and vice-chair Larry Poaster for your support and insights into the work of the Mental Health Funding and Policy Committee. As chair, I found your input invaluable. I also want to extend my special thanks to former chair Linford Gayle, whom I see as a shining example of what can go right if we can transform the current treatment system. I need to extend my special thanks to several members of the MHSOAC staff, notably Janna Lowder, Carol Hood, Beverly Whitcomb, Jose Oseguera and Filomena Yeroshek, among many others.

The reason for this surprising letter is that I have been asked to serve as the executive director of the Financial Crisis Inquiry Commission. This is a congressional commission charged with the responsibility of investigating the causes of the national financial crisis. Our final report is due to the Congress, the president and the public not later than December 15, 2010.

The model for this commission is an investigation and report in the 1930's that explained the causes of the depression. That report substantially shaped modern securities and banking regulation. Our job will be to update that work, taking into account lightening-fast international securities markets, securitization, derivatives, credit default swaps and other new financial instruments. The task—particularly in the given time frame—is daunting but the opportunity to serve the nation is remarkable. In the end, I could not say no to this opportunity.
