- Re: Itemization of Non-medical Consultants Contained in the Fiscal Year (FY) 2013/14 Budget (Object 5152)
- Non-medical Consultants Object 5251 in the County budget is defined as follows: "Service provided by outside consultants in areas such as management services and data processing, services which deal in the relation and application of facts and specialized knowledge to accounting, legal problems: services of draftsman; services provided by registered land surveyors; services provided to determine the value or worth of something; moving and storage services; musicians; program presenters; veterinarian services; all other professional services not included in other service objects. Includes any similar professional services purchased online."

The attached listing is an analysis of each of the non-medical consultants contained in department budgets by fund, department and unit. This memorandum highlights the top 10 budgeted amounts and provides explanations for the expenditures. These top 10 non-medical consultants total nearly \$15 million of the budgeted \$26 million for these accounts.

The radio mast also holds the radio antenna high enough that the radio transmissions from the site are not blocked by adjacent trees or buildings. The term "permanent flow metering site" is somewhat of a misnomer: While a permanent flow metering site may operate for 10 years or more at the same location, two to three of the 47 permanent metering sites will need be taken out of service each year, and new permanent flow metering sites constructed to replace them. The purpose of this \$10,000 line item is to fund a contract (not yet in place) for the removal of radio masts from permanent flow metering sites that have been taken out of service, and the installation of radio masts at new permanent flow metering sites. These are tasks that the PCRWRD Flow Monitoring Group cannot perform.
