#### 1.1 BID PROPOSAL

Any price bid shall be the exact and only price paid by the County to the Producer for the full scope of the Agreement.

#### PART 2 SCOPE, TIMELINE, PAYMENT, AND PAYMENT PROCEDURES

#### 2.1 CONTRACT PRICE AND SCOPE

The contract price includes the cost for the Work specified in the Request for Bids, Bid, Contract Award, and this Agreement, collectively referred to hereafter as Contract Documents; plus the cost of all insurance certificates, premiums, fees required, and all charges, expenses or assessments of whatever kind or character.

#### 2.2 TIMELINE/COMPLETION AND PAYMENT PROCEDURES

A. Producer shall perform video and production of the Duchesne County Fair events under the supervision and control of the Duchesne County Fair Board between August 8, 2016 and August 13, 2016. The length of this Agreement begins from the date of the signing of both the Producer and successful bidder and Duchesne County/Duchesne County Fair Board and will end at the end of the last event on August 13. Obligations under this agreement, if they have not fully been met will continue until the expiration of the statute of limitations.

B. Payment: Duchesne County shall pay fifty percent (50%) of the total contract bid price sixty (60) days before the event begins and the remaining balance paid at the end of the final event.

#### PART 3 LEGAL PROVISIONS

#### 3.1 CONTRACT JURISDICTION, CHOICE OF LAW, AND VENUE

The provisions of this Contract shall be governed by the laws of the State of Utah, Duchesne County, and Duchesne City. The parties will submit to the jurisdiction of the courts of the State of Utah for any dispute arising out of this Contract or the breach thereof. Venue shall be in Duchesne County, in the Eighth Judicial District, Duchesne Department. Vendor agrees to be bound by the decision of Duchesne County in case of any dispute arising from the interpretation or application of the Terms and Conditions.

#### 3.2 LAWS AND REGULATIONS

The Parties signing below under this Contract and any and all supplies, services, and equipment furnished under this Contract will comply fully with all applicable Federal, and State, and local laws, codes, rules, regulations, and ordinances, including applicable licensure and certification requirements.

#### **3.3** INDEPENDENT CONTRACTOR

The Producer shall be an independent contractor, and as such, shall have no authorization, express or implied, to bind Duchesne County, or its members, to any agreements, settlements, liability, or understanding whatsoever, and agrees not to perform any acts as agent for Duchesne County, or its representatives, except as herein expressly set forth. Compensation stated herein shall be the total amount payable by Duchesne County. The Producer shall be responsible for the payment of all income tax and Social Security amounts due as a result of payments received from Duchesne County for these Contract services. Persons employed by Duchesne County and acting under the direction of Duchesne County shall not be deemed to be employees or agents of the Producer.

#### 3.4 INDEMNITY

The Producer agrees to indemnify, save harmless, and release Duchesne County, and all their officers, agents, volunteers, and employees from and against any and all claims, loss, damages, injury, liability, suits, and proceedings arising out of the performance of the Contract which are caused in whole or in part by the acts or negligence of (a) the Producer, (b) the Producer's officers, agents, volunteers, or employees, (c) the Producer's subcontractors, or (d) anyone for

whom Producer may be liable but not for claims arising from Duchesne County's sole negligence. The parties agree that if there are any Limitations of the Producer's Liability, including a limitation of liability for anyone for whom the Producer is responsible, such Limitations of Liability will not apply to injuries to persons, including death, or to damages to property. The Producer's duties contained within this provision do not expire upon the expiration of this contract and will continue until such time all such statute of limitations have expired.

Nothing in this contract shall waive the Governmental Immunity provisions within Utah State Code.

### 3.5 COPYRIGHTS, ETC.

Producer will release, indemnify, and hold Duchesne County, its officers, agents, employees, and volunteers harmless from liability of any kind or nature, including the Producer's use of any copyrighted or uncopyrighted composition of any article or video furnished under the performance of this contract.

#### **3.6 DEFAULT**

Any of the following events will constitute cause for Duchesne County to declare Producer in default of this Contract: (1) Nonperformance of contractual requirements; or (2) A material breach of any term or condition of this Contract.

#### **3.7** AVAILABLE REMEDIES

Duchesne County may do one or more of the following: (1) Exercise any remedy provided by law; (2) Terminate this Contract and any related contracts or portions thereof; (3) Impose liquidated damages, if liquidated damages are listed in the Contract; or (4) Suspend Producer from receiving future solicitations. County shall be entitled to deduct and retain liquidated damages or other damages out of any money, which may be due or become due the Producer under this Agreement. To the extent that the liquidated damages exceed any amounts that would otherwise be due the Producer, the Producer shall be liable for such amounts and shall promptly pay said amounts to the County.

### **3.8** INTERPRETATION OF CONTRACT

Any ambiguities in the contract language shall be liberally construed in favor of Duchesne County.

#### 3.9 SEPARABILITY

Any invalidation of any sections or provisions of this contract will not affect the validity of the remainder of the provision or other provisions in the contract.

#### 3.10 CERTIFICATE OF INSURANCE

Producer shall be able to produce a certificate of insurance with coverage of 1 million per occurrence. Producer shall also have included in their certificate proof of general property damage, bodily damage, and personal injury insurance. Producer shall also show that all employees and agents of producer are covered under workers compensation.

The insurance certificate shall name "Duchesne County, 734 N. Center Street, Duchesne, UT 84021" as a Certificate Holder and cover at the very least the dates of August 8, 2016 to August 13, 2016. Producer shall furnish certificate of insurance sixty (60) days before work shall begin.

#### PART 4 MODIFICATIONS AND TERMINATION

#### 4.1 MODIFICATION

This agreement may be supplemented, amended or modified only by the mutual agreement of the parties. No supplement, amendment, or modification of this Agreement shall be binding unless it is in writing and signed by all parties.

#### 4.2 **TERMINATION**

Either non-breaching party may terminate the Contract upon a material breach by the nonbreaching party. Any performance will be accelerated and due upon the breach and termination of the Agreement.

#### PART 5 MISCELLANEOUS PROVISIONS

#### 5.1 ASSIGNMENT AND SUBCONTRACT

The parties agree that Producer will not delegate performance obligations under this Agreement, in whole or in part, without the prior written approval by the County. Authorization must come from Duchesne County.

Any such delegation of responsibilities is declared as void and will not relieve Producer from any liability or performance obligations under this Agreement.

#### 5.2 ENTIRETY OF CONTRACT

This Agreement supersedes all other Agreements that may have been signed between the Parties prior to date of the Parties signing of this Agreement. This Agreement incorporates by reference all Contract Documents noted above.

#### 5.3 ACKNOWLEDGMENT

The parties understand and have read this agreement and have been provided sufficient time to review it with an independent attorney, or have otherwise refused or elected not to seek legal review. By signing this Agreement, I certify that I am authorized to sign it for the party I am signing it for. I certify that I am capable of understanding this contract and hereby fully understand or have had the opportunity to inquire further into any provision of this contract I do not fully understand and hereby waive any future claim of misunderstanding such terms.
