### PAYMENT AND POLICIES

The cost for this trip is \$2400 per person, double occupancy. Single occupancy supplement is \$600. Price for extension is \$650 double occupancy, single supplement is \$200. Price does not include international airfare, airport transfer, other meals, gratuities, and personal expenses.

A deposit of \$500 is required to reserve a space in this tour. Make checks payable to My Mexico Tours and mail to address below. If you would like to pay by credit card please request an invoice; credit card payments are subject to a 3% fee. Balance is due 30 days before departure, February 14, 2012.

Deposits are fully refundable in full up to 60 days before the tour begins, January 14, 2012. Cancellations made after January 14 are non-refundable but may be applied to another tour, less a \$100 service charge. Cancellations or transfers must be made in writing.
