AN ORDINANCE 47412

AUTHORIZING THE PURCHASE OF 0.1821 ACRES OF LAND LOCATED WITHIN THE URBAN RENEWAL AGENCY CIVIC CENTER PROJECT TEX. R-83 AND UNDER THE MANAGEMENT AND CONTROL OF THE WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO FROM THE SAID TRUSTEES FOR A TOTAL CONSIDERATION OF \$36,000.00; AUTHORIZING THE PAYMENT OF SAID AMOUNT TO THE WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO; AND ACCEPTING A DEED FROM THE WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO FOR SAID PROPERTY.

WHEREAS, the City of San Antonio is constructing a certain perimeter street to the San Antonio Civic Center site which requires that certain property under the ownership and control of the Water Works Board of Trustees of San Antonio be acquired for the completion of such Project; and

WHEREAS, the City and its Water Works Board of Trustees have agreed upon the sale of said property by the Board to the City for the sum of \$36,000.00; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The purchase of a tract of land containing 0,1821 acres out of Block 3, N.C.B. 13814 from the Water Works Board of Trustees of San Antonio for a consideration of \$36,000.00 is hereby authorized and approved.

SECTION 2. Payment of the sum of \$36,000.00 to the Water Works Board of Trustees of San Antonio as consideration for the purchase of the property described in Section 1. above is hereby authorized.

SECTION 3. Said funds shall be payable out of the General Fund, Activity No. 70-01-05, Index Code 415596.

SECTION 4. The Special Warranty Deed executed by the Water Works Board of Trustees for the property described in Section 1. above is hereby accepted.

A RESOLUTION

OF THE WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO AUTHORIZING THE SALE OF 0.1821 ACRES OF LAND OUT OF BLOCK 3, N.C.B. 13814 UNDER THE MANAGEMENT AND CONTROL OF THE WATER WORKS BOARD OF TRUSTEES OF THE CITY OF SAN ANTONIO FOR THE SUM OF \$36,000.00; AND AUTHORIZING THE GENERAL MANAGER OF THE ' WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO TO EXECUTE A SPECIAL WARRANTY DEED TO THE CITY OF SAN ANTONIO FOR SUCH PROPERTY.

C. B. 13814 so that a perimeter road may be constructed by the City of San Antonio in connection with the City's Convention Center site; and

WHEREAS, representatives of the City and the Board have agreed on the conveyance of such property for the sum of \$36,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE WATER WORKS BOARD OF TRUSTEES OF SAN ANTONIO:

1. The sale by the Water Works Board of Trustees of San Antonio of certain City Water Board property containing 0.1821 acres out of Block 3, N. C. B. 13814 to the City of San Antonio is hereby authorized and approved.

2. The consideration for the sale authorized in Paragraph 1. above shall be \$36,000.00.

3. The General Manager of the Water Works Board of Trustees of San Antonio is hereby authorized to execute a Special Warranty Deed to the City of San Antonio and any other instruments necessary to effect the conveyance authorized in Paragraph 1. above.

4. This Resolution shall take effect immediately from and after passage.


