A. Proposed Name or Title of Project/Program:

Montana Site Stewardship

B. Description of Project/Program:

The Montana Site Stewardship program consists of volunteers chosen, trained, educated, and appointed by the Montana State University through Project Archaeology. This program is sponsored by the Bureau of Land Management. Site Stewards are individuals committed to cultural resource preservation, particularly monitoring cultural resources for damage caused by vandalism, theft, or nature.

2. Legislative Authority that authorizes BLM to enter into this AA:

A. Specific legislative authority for this project/program?

Federal Land Policy and Management Act of 1976 (PL 90; Stat. 2743, 43 U.S.C. 1701, 1711, 1737) as amended by PL 98-540 of 1984 (98 Stat. 2718). Authorizes investigations and studies in cooperation with other parties involving the management, protection, and development of public lands, as subject to provisions of applicable law. It instructs the Secretary to coordinate land use planning and management activities with other agencies.

Volunteers for the Public Lands, Section 2 of PL 98-540, included in a 1984 amendment to Section 307 of the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1737). PL 98-540 authorizes the Bureau of Land Management to provide for services or costs incidental to the use of volunteers, including transportation, supplies, lodging, subsistence, recruiting, training, and supervision.

Public Land Administration Act (PL 860649; 74 Stat. 506; 43 U.S.C. 1361). Authorizes cooperation in investigations, studies or experiments involving management of public lands. **Archaeological Resources Protection Act of 1979** (PL 95-96; 93 Stat. 721; 16 U.S.C. 470aa-470ee). Provides for the protection of archaeological resources on public lands and encourages cooperation and exchange of information among governmental authorities, professional archaeologists, and private owners of archaeological materials.

National Historic Preservation Act of 1966, 16 U.S.C. section 470 et seq.

Historic Sites Act of 1935 (PL 74-292; 49 Stat. 666; 16 U.S.C. 461-467). Authorizes, among other things, the Secretary of the Interior through the National Park Service to "...make cooperative agreements with States...to protect and preserve, maintain...any historic or archaeological building, site..."

B. How does the legislative authority apply?

This program would protect public resources through the regular monitoring and documentation

of historic, prehistoric, and paleontological resources on public lands. Public volunteers would coordinate with federal contacts and law enforcement, documenting site conditions and reporting acts of vandalism and looting.

The Site Stewardship Program advocates the following:

- 1. To permanently preserve vital historic, prehistoric, and paleontological sites in order to conserve, study, and interpret them scientifically.
- 2. To expand the public's understanding of the importance of cultural resources and the disorder left by vandals, thieves, and artifact hunters.
- 3. To promote the acceptance and reinforcement of national, state, and local preservation laws and regulations.
- 4. To dissuade site vandalism as well as the illegal trafficking of antiquities and scientifically crucial paleontological materials.
- 5. To enhance communication, understanding, and collaboration among organizations, agencies, tribes, and individuals concerned with the protection of cultural and natural resources.
- 6. To broaden the archaeological and paleontological inventory and increase understanding of those inventories.
- 7. To advocate and perpetuate exceptional criteria for cultural resource examination throughout the state.

B. How does the principle purpose of this proposed agreement support or stimulate a public purpose?

Volunteers attend a two-day training workshop before they become site stewards. Site stewards work in their local areas, in teams coordinated by a professional archaeologist who works for the land management agency responsible for the sites. In this first year the point of contact will be the BLM LFO Archaeologist.

Volunteers regularly visit assigned sites on public lands and report on their conditions to their local coordinating archaeologist, who works for the land management agency responsible for the sites. By consistently monitoring the sites, problems are detected early, when they can more easily be corrected.
