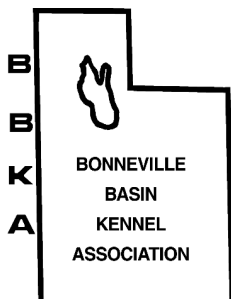

ATTENTION EXHIBITORS

Please clean up after your dogs on the show grounds and at your motel site. We want to retain these facilities for future events.

Remember, all complaints regarding conduct prejudicial to the sport will be dealt with in accordance with AKC rules, by the Show Committee. *This includes dogs relieving themselves on the shrubbery outside the show buildings.*

SMOKING will not be permitted inside buildings - state law. This will be enforced.

The Show Site will be available to exhibitors at 6:00 pm Wednesday, September 14, 2016. Dogs must be removed from the show site immediately following Best In Show judging Sunday, September 18, 2016.

NO VEHICLES ARE ALLOWED ON THE GRASS! Failure to comply will lead to action by the Show Committee. Damages caused by vehicles will be the responsibility of those persons bringing vehicles onto the show site grass areas!

Please be sure that all dogs have current DHL, RABIES & PARVO VACCINATIONS!

EXHIBITORS & AGENTS must be governed by any rules & regulations of the Davis County Parks Department and/or local restrictions.

EXHIBITORS & AGENTS will be held responsible for damages and for keeping the premises clean around their crates and set-ups.

EXHIBITORS & AGENTS must keep dogs under control and restrained at all times.

EXHIBITORS & AGENTS are advised to bring adequate shade for the comfort of their dogs and themselves.

Some shade will be provided near outdoor rings. Crates **MUST** be removed immediately following that breed. This will be enforced by the Show Committee.

NO CRATES within 25 feet of the show rings (outdoors). Crates may be placed against wall (indoors) during specific breed judging and **MUST** be removed immediately following that breed. Day parking exhibitors' ex-pens will be allowed in designated area only. Ex-pens for overnight parking will be in parking only. **NO GROOMING ALLOWED IN THE EXHIBIT BUILDING.**

RESTROOMS will be available for the convenience of exhibitors/spectators. Any exhibitor found bathing or grooming a dog in the public restrooms **WILL NOT BE ALLOWED TO EXHIBIT AND WILL BE SUBJECT TO ACTION BY THE SHOW COMMITTEE.**

NO OVERNIGHT PARKING allowed except in reserved parking areas.

The Bonneville Basin Kennel Association & the Davis County Fair Park assumes **NO LIABILITY** for loss or damage to equipment, property and/or exhibitors and agents.

No strollers will be allowed.

No loose materials such as SAWDUST, CHIPS, shredded paper, etc. will be allowed. Bring mats or other appropriate ground cover.

No dogs will be allowed to be left in the Grooming Building overnight.

NO expens will be allowed in Building #3!

Building #3 will be secured at 10:00 pm each evening for your protection and peace of mind. Building #3 will reopen at 6:00 am each morning for your convenience.

Bathing Stations for Exhibitor's Dogs:

A cement pad with 8 bathing spaces is located approx. 30 yards east of the Grooming Building across from the Equestrian Stall Barn. There will also be a raised dog bathing station provided by Davis County Fairgrounds.

No exhibitors, setups or dogs are allowed in the Stall Barn. No parking along sides of Stall Barn/Fire Lane necessary. Please show respect to your fellow exhibitors & others who use the Equestrian Fair Park.

RING STEWARDING

The Bonneville Basin Kennel Association is offering non-member ring stewards \$30.00 for a full day & \$15.00 for a half day of ring stewarding including lunch.

The Bonneville Basin Kennel Association does not agree to arbitrate claims as set forth on the Official AKC entry form for these events.

A Judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp). Ramps can be used in emergency situation to judge any breed. In an emergency situation an exhibitor has the option of withdrawing their entry and receiving a refund.

The following breeds may be judged on the ground or on a ramp: Lagotto Romagnolo, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirneco dell'Etna, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs and Norrbottenspets (Misc).

The following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows.

NEW EXHIBITOR BRIEFING on Saturday. Check Judging Program for time & location.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks.

RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$3.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.

EXHIBITORS NOTE: Please notify Superintendent of any change of address.

BBKA RESERVED GROOMING REQUEST

This year Bonneville Basin Kennel Association is providing reserved grooming space for the exhibitors. The grooming spaces are approx. 7 x 7 feet and have access to electric power. The reserved grooming spaces are in Building #3, as in past years. Loading and Unloading parking is the same as in past years.

- Building #3 will be open at 6:00 am each day, Thursday through Sunday. Building #3 will close nightly at 10:00 pm
- Reserved Grooming will be available for set up on Wednesday beginning at 4:00 pm
- Cost is \$20.00 per grooming space for the 4 days. No reservations will be accepted for less than the 4 days.
- The grooming area will be monitored throughout each day for the duration of the shows. Please keep your space clean. Exhibitors are responsible to keep their area(s) clean. Failure to follow the instructions of a show committee member can result in forfeiture of a reserved space.
- Electric power is available throughout the building and must be shared. No space has exclusive use of any outlet.
- No dogs will be left overnight in the Grooming Building.
- No dogs are to be left unattended on grooming tables at any time. This is the sole responsibility of the exhibitor.
- No bathing allowed in the Grooming Building or in the public restrooms.
- No Exercise Pens are allowed in the Grooming Building.
- The safety and welfare of all dogs is the sole responsibility of the exhibitor. Up to 3 spaces per Reservation form, no more than 2 reservation forms per envelope for a total of 6 spaces. BBKA can only guarantee 6 contiguous spaces.
- Reservations will be confirmed if a self addressed, stamped envelope is provided.
- Reservations are limited and will be returned unopened if the limit is reached. Exhibitors may be contacted by phone or Email if time permits.
- Bonneville Basin Kennel Association is not responsible for lost or stolen items.

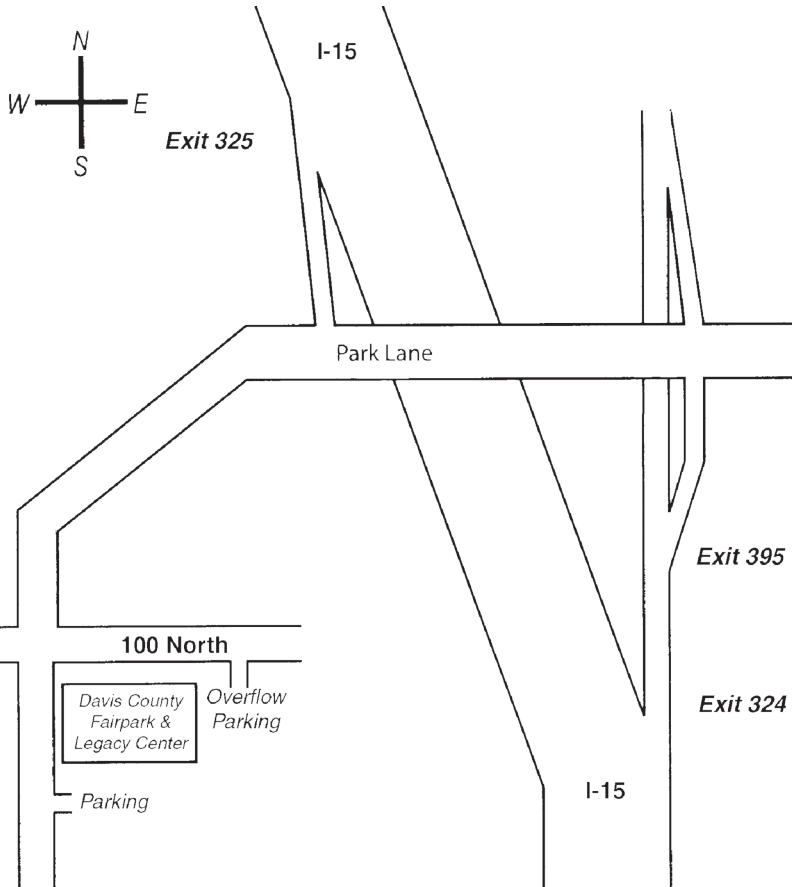

All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

***A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any during the cluster/weekend.*

AKC Sanctioned Beginner Puppy Competition!

JUDGE: Mrs Pat M Jenkins

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

Entry Fee: \$12.00 (including AKC recording fee of \$2.00 for each dog. These fees are paid to the American Kennel Club.)

Entries will close Wednesday Noon, August 31, 2016 at Superintendent's office.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767.
