After an extensive bidding process, the Village selected MC Squared Energy Services, LLC (mc²), to provide eligible residents and small business customers with electricity supply savings. There is nothing you need to do in order to participate and enjoy this savings. mc² will automatically process your enrollment, unless you return the enclosed Opt-Out card within 14 days of the postmark date on this notice.

**Your Low Electricity Rate:** As an eligible member of this program, you will receive the mc<sup>2</sup> electricity supply rate identified below through your August 2014 billing cycle. For additional information, please see the enclosed terms and conditions.

**Switching is Automatic:** There is no switching fee from ComEd or from mc<sup>2</sup> and you do not need to do anything to participate. Your switch to mc<sup>2</sup> will occur automatically on the first available meter read date in August. After you are enrolled, ComEd will send you a letter confirming your selection of mc<sup>2</sup>. Please see the enclosed terms and conditions for more information.

**Your Opt-Out Option:** You are not obligated to participate. If you wish to be excluded from this opportunity and remain with your current provider, you have until 14 days from the postmark date on this notice to return the enclosed Opt-Out card.
