3. Description- Description of violation code (30 character max).
4. Class- charging classification. Double asterisks (**) represents multiple classifications available per class reference.
5. Class Reference- charging reference for classification.
6. Victim Code- violation qualifier.

Victim Code Key:

A= Vulnerable Adult M=Minor L= Law Enforcement
C= Dangerous Crime-Child D= Domestic Violence

7. Effective Date- date the violation was signed or updated per legislature.
8. MVD- Motor Vehicle Division reportable flag.
9. DPS- Department Public Safety reportable flag.
