NEW: Working - Walking Surfaces - A leading cause of worker-related injury & death comes from slipping, tripping, or falling from work surfaces such as floors, platforms, portable & fixed ladders, stairs, & ramps. This course will review the changes to subparts D & I of 29 CFR 1910 that contains occupational safety standards for general industry.

NEW: Silica in Construction - This course will describe the silica in construction standard, review of Table 1, written exposure control plan, competent person, housekeeping & medical exams. Employers are required to be in compliance by 6/23/17 for construction.

OSHA 300 Log Recordkeeping - This course will describe recordkeeping requirements, maintenance of the OSHA 300 log, reporting of fatalities, hospitalizations, amputations, & loss of eye, review of policies that may be discriminatory to a worker reporting an injury or illness, & the electronic scanning of the 300 log, 300A & 301.

<u>Basic Safety</u> – This course emphasizes the identification & control of the most cited safety standards in general industry; walking working surfaces, emergency procedures, personal protective equipment (PPE), machine guarding, lock out/ tag out (LOTO), & electrical.

02/08 – Jackson – TCCI 02/22 – Johnson City – TCCI 03/10 – Mt. Juliet – TCCI 07/26 – Knoxville - TAUD

Maintenance Related Standards – This course emphasizes the identification & control of the most cited standards in maintenance; lock out/ tag out (LOTO), machine guarding, electrical, permit confined spaces, housekeeping, egress routes, emergency procedures, fire safety, compressed gas safety, & health hazards.

TOSHA's Dental Local Emphasis Program -

This course will describe TOSHA's new compliance Local Emphasis Program (LEP) for Dentistry; focus on prevalent hazards & the standards that apply, exposure to blood, safer medical devices, hazardous chemicals, & ergonomics.
