Policies

If Client will be delayed in returning home and additional pet care is required, Client agrees to pay for any additional services immediately upon their return.

Client agrees that Pick of the Litter Pet Sitting is not liable for injury to, or loss of, any pets allowed, at the direction of the Client, access to a doggie door, or allowed outside the Client's house off leash or unattended. If applicable, Client's initials here: X indicate that the Client understands this clause and does request their pet(s) be allowed outside of Client's house off leash, and/or to have access to a doggie door. Additionally, if any insurance claim arises from such conduct, Client agrees to pay insurance deductible of \$500.00.

Client agrees to reimburse Pick of the Litter Pet Sitting for any expenses incurred for supplies needed that were not left by Client.

If Client requests that Pick of the Litter Pet Sitting return house key(s) following the conclusion of a job, Client will be charged the equivalent of one visit for the return trip.

Pick of the Litter Pet Sitting accepts no responsibility for security of the premises or loss if other individuals have access to the home during the time Pick of the Litter Pet Sitting will be caring for Client's pet(s). Pet care will be performed only by Pick of the Litter Pet Sitting during all assignments unless prearranged with Client. Further, Pick of the Litter Pet Sitting is not responsible for unsecured access to property (i.e. unlocked gate).

Client agrees that Pick of the Litter Pet Sitting shall not be held responsible for any damage to Client's property, or that of others, caused by Client's pet(s).

Pick of the Litter Pet Sitting is not responsible for any choking, electrocution, or other harm *caused by objects left by or authorized by Client* (bones, rawhides, electrical cords, etc).

Client agrees that it is their responsibility to notify Pick of the Litter Pet Sitting of any pet that has ever caused an injury to any human or other pet. Further, Client will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Client agrees to hold Pick of the Litter Pet Sitting harmless in the event of a claim by any person injured by the pet.

Prices are subject to change at the discretion of Pick of the Litter Pet Sitting. In the event of a price increase, Client has the right to cancel services with no cancellation fee. Holiday rates apply for future bookings on and around holidays.

Client authorizes this contract to be valid approval for future services so as to permit Pick of the Litter Pet Sitting to accept future reservations by telephone or e-mail and enter my premises without additional signed contracts. In addition, Client understands that any and all cancellation fees will apply for future bookings.
