#### **CHANGES AND/OR ADDITIONS:**

Offer Agreement, page 6 of 15, Unit Prices has been revised and is attached to this addendum. Please submit the revised Page 6 as a part of your bid.

## **QUESTIONS/ANSWERS:**

Q. 1) Does this solicitation include off-road or construction style equipment that is owned by such departments as DEQ, Transportation, and/or Wastewater?

A. 1) No. This solicitation is for County owned vehicles only.

Q. 2) Does this solicitation include seized (RICO) vehicles?

A. 2) No. This solicitation is for County owned vehicles only.

Q. 3) Are the estimated annual usage quantities correct for Line Items 2 and 10 for both Groups 1 and 2? A. 3) Yes, quantities 100 & 35 – Group 1 and 30 and 15 - Group 2 represent the estimated additional miles past the basic tow area of 9.0 miles.

Q. 4) Group 3, is the Unit of Measure (UOM) per unit towed and is line 1, four (4) estimated trips and not five (5)? A. 4) Yes, the UOM is per unit towed and the estimated number trips has been corrected and now reads four (4).

Q. 5) By law drivers are allowed to drive a maximum of ten (10) hours, therefore, trips to Kingman, for example, would require overnight accommodations. Can a line item be added to accommodate such instances? A. 5) Yes, a line item has been added and page 6 of 15, Unit Prices, has been revised.

All other requirements and terms of the Solicitation remain unchanged. Failure to include acknowledgment of all addenda may be cause for rejection.
