## Non-Construction Projects: ARC Application Guide

Project applications should be submitted to the state ARC office. Applications should be arranged in the following <u>section</u> sequence and should include the following information.

		<ul> <li>2) Purpose, Description, &amp; Rationale – <ul> <li>a. Describe specific problems or issues the project will address and how these issues impact the community.</li> <li>b. State in one sentence the main purpose of the project in terms of the goal and strategy being addressed (e.g., To create jobs by providing training for small business owners.)</li> <li>c. Provide a detailed description of all major project activities, including: what will be done, who will complete each activity, and a timeline for starting and ending the project.</li> <li>d. Explain why the proposed approach is the most beneficial.</li> <li>e. Describe accomplishments and progress to date if continuing an ongoing program (whether or not ARC funded).</li> <li>f. Illustrate local demand for the project (e.g., letters from key stakeholders, customer data).</li> </ul> </li> </ul>
		3) Relation to Other Local/Regional Activities – Describe how the project meets the priorities of local or regional community or economic development plans, and describe efforts to coordinate the project with other area economic development activities.

SECTION 3 PROJECT NARRATIVE (continued)  6) Agency Capacity, Staff & Consultant Qualifications, and Procurement Procedures —  a. Briefly review the applicant's capacity to undertake the proposed activity by describing previous experience with relevant activities.  b. Describe the qualifications needed for key individuals who will manage and operate the project. Attach position descriptions or brief resumes.  c. Describe proposed qualifications for all consultants and subcontractors, and describe the competitive procedures used to select them.  7) Funding Need and Sustainability —
<ul> <li>a. Identify each funding source for the project and the status of each funding commitment.</li> <li>b. Detail why ARC funding is needed at this time.</li> <li>c. Explain the applicant's strategy for ensuring the project's long-term sustainability (once ARC funds are no longer available), including efforts to secure other sources of support for future operations.</li> </ul>
SECTION 4 BUDGET INFORMATION and SUPPORTING MATERIALS
Detailed budget and budget narrative —     a. Provide a detailed budget that includes sources and uses of ARC funds <u>and</u> all non-ARC matching funds.     b. Provide a budget narrative that explains expenditures by line items shown on the SF424A.
2) Calculations of match – For multi-county projects with more than one ARC designation (i.e., distressed, transitional, at-risk, competitive, attainment), show calculations to confirm the project meets ARC match requirements.
3) Letters of commitment – Include letters citing specific amount of funds committed from all matching fund sources. Provide descriptions of specific in-kind resources including the methods used to determine their value.
4) Clearinghouse documentation (if required by state)
<b>Additional Documentation:</b> Enclose pertinent supporting materials that will lead to a better understanding of the proposed project. Please <u>do not</u> include form letters or financial audits.
