We are pleased to announce the release of AMH Behavioral Health System Version 4.0. This software has been verified in the following environment:

1. Cache Version 5.0.21
2. Kernel Version 8.0 through Patch 1014
3. VA FileMan Version 22.0 through Patch 1003
4. XB Version 3.0 through Patch 11

The required software for AMH Behavioral Health System 4.0 is listed below:

- Kernel Version 8.0 or higher
- FileMan Version 21 or higher
- IHS PCC Suite Version 2.0 (bjpc0200.k)
- 2010 ICD Updates (aum_1010.k)
- IHS RPMS Behavioral Health System Version 3.0 through Patch 10 (amh*3.0*10)

With the exception of any routines that handle any transfer of data, the M routines were tested and functioned properly on the Software Quality Assurance Team's platform.

The AMH Behavioral Health System Version 4.0 package was tested at: **Chief Gall Aberdeen Area Youth Residential Treatment Center, Shingle Springs Tribal Health Center, Gallup Indian Medical Center, and Phoenix Indian Medical Center.**

The routines and documentation adhere to the 2009 RPMS Programming Standards and Conventions.
