SUBJECT: FEHB Open Season: Significant Plan Changes

GENERAL

Purpose

This Letter transmits lists of significant events affecting certain health plans during the upcoming FEHB open season. Some of these events will require action on the part of agencies.

TERMINATIONS

Attachment 1

These plans are dropping out of the FEHB Program at the end of 1996.

What Must Employees Do?

Employees in these plans must choose a new health plan during open season.

Employees who do not choose a new health plan will be considered to have cancelled their coverage and will not have health benefits for 1997.

New Coverage

Coverage under an enrollee's "new" health plan will be effective the first day of the first pay period beginning on or after January 1; for most employees, this will be January 5. Enrollees will remain covered and receive benefits under the "old" plan or code until the new coverage becomes effective.

**Plan
Notification**

Each plan on the list is supposed to notify its enrollees of the plan's withdrawal and the need to select a new health plan for 1997. However, some plans' enrollment records and address lists may not be up to date.

Attachment 2

These plans are terminating an enrollment area that has a separate enrollment code.

Employees in the terminating enrollment area must choose a new plan during open season, since their enrollment code will no longer be valid.

The effect of such a termination and the actions required of both agencies and employees are the same as if the entire plan were terminating.

**What Must
Agencies Do?**

Agencies must notify employees in these terminating plans and enrollment areas of the need to select a new health plan to avoid losing coverage. This is especially important since many employees will not receive a copy of the FEHB Guide and will therefore be unable to check the comparison chart to see if their plan will still be participating in 1997.

We strongly recommend that you notify employees by distributing copies of these lists to each employee, along with your agency's notice to employees about open season.

We also recommend that, before the end of open season, you follow up with employees in these plans who have not submitted an SF 2809 and remind them to select a new health plan.

Belated Changes

Despite these precautions, there will be some enrollees who do not "get the word" to change health plans during open season. We encourage you to be liberal in using your authority to accept belated open season changes from employees enrolled in a terminated health plan.

ENROLLMENT AREA REDUCTIONS

Attachment 3

These plans are significantly reducing an enrollment area, but it does not involve terminating an enrollment code. Enrollees in the area being eliminated should choose a new health plan for 1997.

Enrollees who do not choose a new health plan during open season will have to travel to the plan's service area to obtain medical care in order to receive full benefits from the plan.

Agency Action Required

You may wish to distribute a copy of this list to each employee, along with your agency's notice to employees about open season. If you don't distribute the lists, remind employees to check their health plan brochure carefully to see if there have been any changes to the plan's enrollment area which would affect them and to change to a new health plan if necessary.

OTHER ENROLLMENT AREA CHANGES

Attachment 4

This plan is splitting its current enrollment area into two separate areas with different enrollment codes. Enrollees should check the plan brochure to determine which code they should be under and, if necessary, complete an SF 2809 to change to the correct enrollment code.

Enrollees who should change codes, but don't, will have to travel to the area served by their enrollment code to obtain medical care in order to receive full benefits.

Attachment 5

These plans are splitting their current enrollment area into two separate areas with different enrollment codes. Enrollees should check their plan brochure to determine which enrollment code they should be under and, if necessary, complete an SF 2809 to change to the correct enrollment code.

Enrollees who should change codes, but don't, will still have free access to all plan providers. However, they will pay a higher premium.

Attachment 6

This plan is transferring a service area from one existing enrollment code to another existing enrollment code. Enrollees should check the plan brochure to determine which enrollment code they should be under and, if necessary, complete an SF 2809 to change to the correct enrollment code.

Enrollees who should change codes, but don't, will still have free access to all plan providers. However, they will pay a higher premium.

Attachment 7

These plans are consolidating enrollment areas, i.e., changing from two enrollment codes to one enrollment code. The enrollment areas will remain the same; however, they will be included under one enrollment code. Enrollees in the "departing" enrollment code will be transferred automatically to the remaining enrollment code.

Attachment 8

These are new plans entering the FEHB Program in 1997. We have indicated the general area served by each plan.

Attachment 9

These plans are expanding their enrollment area, with the new area having a separate enrollment code. We have given a general description of the expanded areas.

Attachment 10 These plans are significantly expanding their enrollment area without adding a new enrollment code. We have included a general description of the expanded areas.

Agency Action Required Be sure to include these new plans and expanded enrollment areas when you count the number of eligible employees and place your orders for brochures.

MISCELLANEOUS CHANGES

Attachment 11 These plans are merging with another plan at the end of 1996. Enrollees in the "old" plan(s) will be transferred automatically to the "new" plan and need take no action. Any enrollees in the "old" plan(s) who do not wish to be transferred to the "new" plan must choose a different health plan during open season.

Attachment 12 These plans have changed their names for 1997.

Attachment 13 These plans have changed enrollment codes. Enrollees in these plans will be transferred automatically to the new enrollment code.
