Revised REG 656 Form

Revised Form

The Application for Lien Sale Authorization and Lienholder's Certification (REG 656 REV 06/10) form has been revised. The revised REG 656:

- Changes the Lien Cost field language from, "As of (Date) the amount and basis for my lien is: Lien Cost (maximum \$100)," to simply "Lien Cost."
- Adds a note to, "Refer to Civil Code Section 3074 when calculating maximum lien sale cost."

Procedures

Order the revised REG 656 using existing procedures or access the revised REG 656 on the DMV website at **www.dmv.ca.gov**. Once the REG 656 (REV 06/10) forms are obtained, destroy older versions.

Any version of the REG 656 will be accepted through December 31, 2010. However, as of January 1, 2011, only the REG 656 (REV 06/10) will be accepted. Applications containing older versions of the REG 656 will be returned on a Report of Deposit of Fees (RDF).

Background

Civil Code (CC) §3074 states that a lienholder may charge a fee for lien sale preparation not to exceed \$70 for a vehicle valued at \$4,000 or less and not to exceed \$100 for a vehicle valued over \$4,000. The CC does not allow more than 50 percent of the allowable lien costs to be charged until lien sale notifications are mailed to interested parties and the lienholder or registration service has possession of the required lien processing documents.
