Definition of Terms:

For the purposes of this survey:

A financing is considered "made" in the year in which the BIDCO first disburses any proceeds of the financing, or such earlier date on which the financing documents are executed obligating the BIDCO to disburse funds.

SIC code numbers and classifications of businesses are those used in the Standard Industrial Classification Manual, 1987 of the Executive Office of the President, Office of Management and Budget. Where the financing recipient is in more than one line of business, indicate the SIC code which is representative of the line of business receiving the greatest benefit from the financing.

"Minority" means Black, Hispanic, Oriental (this is defined below), Eskimo or an American Indian who is not less than one-quarter (1/4) quantum Indian blood as certified by the person's tribal association and verified by the Indian Affairs Commission.

"Oriental" (Asian or Pacific Islander) means all persons having origins in any of the original people of the Far East, Southeast Asia, the Indian Subcontinent, or the Pacific Islands.

"Minority owned" means that more than 50 per cent of the voting shares or interest in the business is owned, controlled and operated by individuals who are members of a minority and with respect to which more than 50 per cent of the net profit or loss attributable to the business accrues to shareholders who are members of a minority.

"Woman owned" means that more than 50 per cent of the voting shares or interest in the business is owned, controlled and operated by women and with respect to which more than 50 per cent of the net profit or loss attributable to the business accrues to women shareholders.
