This schedule must be completed if you did not receive a "Receipt for Qualified Education Expenses" from your students' school and want to take a credit for qualified education expenses on Form IL-1040.

STOP You may not include expenses paid to a daycare, preschool, college, university, independent tutoring service, or trade school when figuring this credit.

In order for your education expense credit to be properly processed, you must write on your Form IL-1040,

- ➔ **Line 21a**, the total amount of education expenses paid for your students during the calendar year, (Schedule ED, Step 2, Line 1), **and**
- ➔ **Line 21b**, the amount of your education expense credit (Schedule ED, Step 2, Line 10).
