

Dear Friends,

Happy New Year! It continues to be an honor and privilege to serve as your State Representative. The 2007 Legislative Session will be one of our most important as we decide which initiatives, programs and services we fund with our significant budget surplus. I am committed to working together with government agencies, community groups and individuals like yourself, by introducing and supporting initiatives that will bear the most fruit towards improving our quality of life. You will find below a list of some of the proposals that have come up for discussion this year.

Your input and ideas are always welcomed. Please note in this newsletter our Community Survey and Invitation to our first Liliha-Nuuanu Candlelight Tour.

Aloha.

Helping Those Who Need It Most: 1) Tax relief to help families with children or aging parents, working couples, and struggling individuals. 2) Ensure adequate State support for developing, constructing, repairing, improving, and maintaining affordable housing.

Investing In Education: 1) Engage middle school students with math, science, engineering, problem-solving and teamwork concepts in a project-based contextual learning environment. 2) Teacher incentives to include professional development through a University of Hawaii training program for elementary, middle and high school math and science teachers. 3) An annual state tax deduction of \$10,000 for single filers and \$20,000 for dual filers for higher education savings accounts.

Increasing Access to Affordable Health Care: 1) Increase the number of nurses and help doctors reduce their malpractice costs. 2) Support current hospitals and allow additional hospitals to be built.

Protecting Our Citizens: 1) Toughen penalties for those who use illegal drugs and abuse alcohol, and establish a pilot program for abuse intervention and treatment. 2) Clarify "knock and announce" rules so that police officers do not have to jeopardize their personal safety before entering a suspected crime location and enable personnel to reasonably obtain DNA samples from convicted felons who refuse to comply. 3) Increase penalties against security brokers who target or injure senior citizens and make it a requirement that financial institutions report suspected financial abuse when directed to our kupuna.

Representative Corinne Ching Founds the Heritage Caucus

In an effort to preserve what is unique and cherished in our islands and especially in our own Liliha, last year I founded the Heritage Caucus, a bipartisan, bicameral body. My Co-Chair Representative Cindy Evans (D-North Kona–South Kohala) and I were both concerned that important buildings and historic sites could be lost if we did not emphasize it during this time of growth and development throughout our state. Other legislators joined us to support historic preservation and promote the traditional art forms and heritage of Hawaii's many cultural groups. Some of the legislation introduced by the Caucus:

- HB 2857 (Act 45) (enacted into law) makes a knowing violation of the conditions of an approved mitigation plan that includes monitoring and preservation plans a civil and administrative violation.
- SB 819 (passed) clarifies that penalties and fines collected under Chapter 6E, Hawaii Revised Statutes to be used towards the preservation of Hawaii's historical sites and structures.
- SCR 211 (passed) supports the creation of a four-year degree program in historic preservation.
- HCR 320/HR 256 (passed) requests the Board of Land and Natural Resources to honor the first Monday in May as "Historic Preservation Awareness Day" by holding events that will stimulate public interest in historic preservation.
