INSTRUCTIONS FOR FILING 24-HOUR REPORTS

INSTRUCTIONS FOR ALL CANDIDATES

All legislative and county candidates must file a 24-Hour Report to disclose contributions (including loans from the candidate and candidate's spouse/domestic partner) aggregating more than \$1,000 or more from a single contributor and single expenditures of \$1,000 or more made during the 24-hour reporting periods listed below.

24-HOUR REPORT PERIOD FOR THE 2012 ELECTIONS		
For the 2012 elections, these requirements apply if the contribution and/or expenditure occurs between		
For the Primary Election:	May 30, 2012 through June 11, 2012	
For the General Election:	October 24, 2012 through November 5, 2012	

Due to contribution limits, only the candidate and the candidate's spouse or domestic partner are allowed to make contributions that could aggregate more than \$1,000.

The report must be filed within 24 hours of receiving the contribution or making the expenditure, including weekends and holidays.

FACSIMILE TRANSMISSION

A properly signed report may be faxed to the Ethics Commission, provided the original is received by the Commission within 5 calendar days. The Commission's fax number is (207) 287-6775.
