Thank you for your interest in leasing and gardening property owned by the Michigan Land Bank Fast Track Authority. The mission of the Michigan Land Bank is to stimulate economic growth and community revitalization, in a strategic and progressive manner, by fostering creative partnerships and utilizing land bank programs and tools in order to restore property to a productive use.

Property eligible for the program must be (1) owned by the Michigan Land bank; (2) a vacant lot; (3) zoned residential; and (4) in the opinion of the Michigan Land Bank, not part of a proposed plan or development requiring land assembly.

Garden for Growth lease cost: \$25 for one year or \$75 for three years. Lessee will have the option to renew the lease at the end of their lease term.

Instructions:

 - Proof of paid property taxes (copies of current paid city <u>and</u> county tax bills)
 - Proof of identity (copy of valid state driver's license or other official photo ID)
 - Current photo of the property

- 2. Within 30 days of receipt of your completed application and all required documentation, the Michigan Land Bank will complete its review and notify you whether it is approved or declined.
- 3. If your application is accepted, the Michigan Land Bank will send you an acceptance letter, invoice for payment, and lease agreement to be signed and returned within 14 days of receipt.
- 4. Upon receipt of your payment and signed lease agreement, the Michigan Land Bank will execute the lease and mail you a copy for your records.
