Registration Policy

Due to the overwhelming amount of registrations, and a high no show rate, we have been forced to limit class sizes to only individuals who have pre-registered on line. In addition, registration is limited to those who are actively employed by a agency provider, solo provider, parent, individual receiving services, or have successfully completed the New Med Waiver Provider Orientation training. Registration MUST be done on line and will end one week prior to the start of the class. You must bring your confirmation letter and registration form along with your photo ID to each training. If you can not find your name on the sign-in sheet this means our agency has not received your registration form. You will not be allowed to attend the training if you have not pre registered on line.

Please plan to be on time. Sign-in time starts 30 minutes prior to the class. The Benton Building opens at 8:00 AM. The doors will be closed five minutes after

the scheduled start time, so please allow time for parking and registration. Parking is limited, so allow some extra time to find an available space. **You can park in the city parking garage on Avenue A, on the street or in the Health Department parking lot across from the back parking lot of the Benton Building. Please do not park in the visitor's lot.**

- Please call to confirm the status of training. Dates are subject to change.

Issues around fire safety and fire prevention are also discussed. **This training is mandatory annually for all providers providing supports to individuals in residential group home facilities as well as those in supported living and waiver support coordinators.**

It is the responsibility of all APD operated, contracted or licensed providers and Medicaid Waiver providers, and their subcontractors, and ICF/DD licensed and regulated by agency or Health Care Administration, to report incidents to APD in accordance with operating procedure No.10-002.

The health, safety and well being of supported individuals (consumers) and staff are the primary responsibilities of the Agency and service providers. Discussion will also focus on the legal authority (Florida Statutes 393.) governing the use of Mechanical, Chemical, and Manual restraints, and reporting procedures. This class will cover 65G (8) which covers the use of reactive strategies. On 8/7/2008 revised Chapter 65G-8 Reactive Strategies Rule became effective. Some of the Rule has an effective date of 8/1/09 in order to allow time for providers to come in to compliance. This rule is mandated in regards to any intervention.
