It's time to order MnVFC influenza vaccine for the 2012-13 influenza season. As in years past, the MnVFC program only provides influenza vaccine for eligible children 18 years of age and younger.

Adults age 19 and older on a Minnesota Healthcare Program (MHCP) are not eligible for MnVFC vaccine. If you see MHCP adults you can use private stock and submit a claim to the patient's insurer.

### How to Order Influenza Vaccine

Reminder: Starting July 1, 2012, MDH will no longer be able to provide MnVFC vaccine for underinsured children in private clinics. However, underinsured children will still be able to receive MnVFC vaccine at public clinics (i.e., Federally Qualified Health Centers (FQHC), Rural Health Centers (RHC), local public health (LPH), Indian Health Services (IHS), and tribal clinics). Please consider this change when placing your order and adjust accordingly.

- Do not do both or you may receive double the amount of vaccine you really need!
- Not ordering influenza vaccine? Please submit an order form even if you are not ordering influenza vaccine. You can do this by:
  - Selecting the "No, I do not wish to prebook influenza vaccine from the Minnesota Department of Health" option online.
  - Placing an X in the box next to "Please check here if you will NOT be ordering influenza vaccine" on the paper form.
- To ensure your order in a good match to your MnVFC patient population, we'll compare it to your *Annual Report of the Number of MnVFC Patients Immunized*.

Influenza vaccine orders are **due by March 9**, **2012**. We will let you know as soon as possible when you will receive your influenza vaccine.

#### **Vaccine Product Information**

- The strains for the 2012-2013 trivalent influenza vaccine are still being decided, more to come.
- Both inactivated (TIV) and live attenuated (LAIV) flu vaccine products are available (i.e., Fluzone and FluMist).
- Be sure to order enough thimerosal-free influenza vaccine (i.e., Fluzone pre-filled syringes and FluMist) for children whose parents may request it.
- The MnVFC program will make every effort to fill your request, but we may need to make adjustments based on product availability.
- As you prepare your order, keep in mind that LAIV is growing in popularity among children and adolescents (parents too!).

# Still Have Influenza Vaccine from this Year (2011-12)?

- Keep vaccinating flu season isn't over yet!
- Try to finish the second dose in infants and children who need it. You can continue to do so until the vaccine expires.
- Check influenza vaccine expiration dates. The expiration date for inactivated flu vaccine is June 30 of each year. Expiration dates for LAIV vary as it usually expires much sooner than TIV.
- If you have expired and unused MnVFC influenza vaccine, please contact the MnVFC program before returning it to the distributor, McKesson.

This order form must be signed by a licensed practitioner who is authorized to procure vaccine/biologicals according to Minnesota Statutes, Section 151.37 (e.g., M.D., D.O., nurse practitioner, physician's assistant, or pharmacist). Please include the individual's title. Signature and title (M.D., D.O., N.P., P.A., or R.Ph. only)

#### \*Preservative-free vs. thimerosal-free

Vaccines with trace amounts of thimerosal are labeled as preservative-free. Vaccines that do not contain any thimerosal are labeled as thimerosal-free.

Thimerosal is still used in the early stages of manufacture of a few vaccines to ensure the production line is sterile. It is removed through a purification process, with only trace remaining (about 1/100th of the amount found in older vaccines).

If you prefer to receive a different brand of flu vaccine than is listed on the order form, please send an email to health.MnVFC@state.mn.us. Once we become aware of which brands are available on the federal contract, we will email you an order form including any additional brands offered on the federal contract.
