Gravely and Snider are Recognized for Test Burn Help

RFAAP recently conducted a Compliance Stack Test at the Explosive Waste Incinerator. Because the test burn continued longer than planned there was insufficient waste AA2 paste on-hand to complete all three 3-hour stack tests. Calls were placed by Wanda Jones, Incinerator Forman, to Wayne Snider, Shift Supervisor 4th Rolled Powder. Wayne contacted Clinton Gravley, 4th RP Operator, who promptly prepared and delivered enough AA2 paste so that the stack test was completed as scheduled. The Environmental Department wishes to thank these employees for their cooperation and teamwork on such short notice.

Cleaning Up Absorb-All

Do not leave piles of absorb-all on lubricant spills. Dispose of it properly as follows:

- Sweep it up immediately.
- Double bag it with no free liquids inside the bag.
- Seal the bag by tying a knot on the open end or by using a zip tie.
- Label the bag "petroleum debris." Also note the location of the spill and the type of oil, if possible.
- Take the bag to the petroleum roll-off at either the Air Curtain Destructor (Building 425) - call Dean Nunley first, at (540) 239-1595, to make sure arrangements to enter.

Freeze Water Use

With the temperatures starting to dip into the 30s and with frost warnings out, many operating areas will soon be using freeze protection water. Its use significantly increases water flow to the Bioplant. To decrease the amount of freeze water discharged to the Bioplant, there are several things you can do:

1. When freeze water is necessary, it doesn't have to be a full flow just a trickle is adequate for all situations.
2. Keep doors and windows shut to conserve heat and energy.
3. When temperatures rise above freezing and the danger of line freezing is past, turn off the freeze water, even if it's only a trickle.

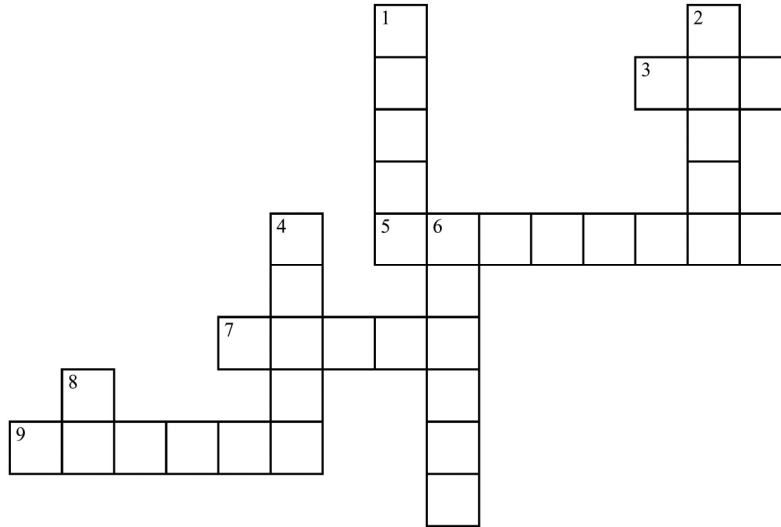
