ARKANSAS GAME & FISH COMMISSION RESIDENT LICENSE PRIVILEGES

- FSH \$10.50** **Resident Fisheries Conservation License:** Entitles holder to FISH the waters of the state with non-commercial tackle. A Code (TPR, \$5.00) must also be purchased to retain trout.
- TPR \$5.00** **Trout Permit Resident:** In addition to (FSH) Resident Fisheries Conservation License or (RT3) Resident 3 Day Trip Fishing License, entitles holder to retain trout and is required to fish certain waters. (See Regulations). **(NO STAMP IS ISSUED).**
- RS \$25.00** **Resident Sportsman's License:** Entitles holder to take total bag limit of deer, hunt all species with modern gun, muzzleloader, and archery/crossbow tackle. A Duck Stamp (Code DSR) must also be purchased to hunt waterfowl. **A (HNT) may not be traded later for a (RS). Expires on June 30th.**
- HNT \$10.50** **Resident Wildlife Conservation License:** Entitles holder to HUNT all small game and to take only one (1) deer with modern gun. A Duck Stamp (Code DSR) must also be purchased to waterfowl hunt. **The (HNT) may not be traded later for a (RS). Expires on June 30th.**
- ***SPORTSMEN DESIRING TO DO THE FOLLOWING MUST PURCHASE A (RS)*****
1. Take more than ONE DEER. The (HNT) entitles holder to take only one (1) DEER WITH MODERN GUN.
 2. Hunt with archery/crossbow or muzzleloading equipment.
 3. Hunt Bear, Turkey, or Elk.
- DSR \$7.00** **Arkansas Resident Waterfowl Stamp:** In addition to Resident hunting license, entitles holder to hunt waterfowl. **Expires on June 30th.**
- DFS \$15.00** **Federal Waterfowl Stamp:** Required for waterfowl hunting in addition to the Resident hunting license and the Arkansas Resident Waterfowl Stamp (see DSR). **Expires on June 30th.**
- LBT \$20.00** **Leased Land Permit - Big Timber WMA:** Entitles holder to hunt & trap on Big Timber WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LCJ \$20.00** **Leased Land Permit - Casey Jones WMA:** Entitles holder to hunt & trap on Casey Jones WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LCH \$20.00** **Leased Land Permit - Cherokee WMA:** Entitles holder to hunt & trap on Cherokee WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LGF \$20.00** **Leased Land Permit - Gum Flats WMA:** Entitles holder to hunt & trap on Gum Flats WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LJK \$20.00** **Leased Land Permit - Jim Kress WMA:** Entitles holder to hunt & trap on Jim Kress WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LLC \$20.00** **Leased Land Permit - Lafayette County WMA:** Entitles holder to hunt & trap on Lafayette County WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LPR \$20.00** **Leased Land Permit - Provo WMA:** Entitles holder to hunt & trap on Provo WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- LMP \$20.00** **Leased Land Permit – Moro Big Pine WMA:** Entitles holder to hunt & trap on Moro Big Pine WMA Leased Lands. (ALSO REQUIRES A VALID HUNTING LICENSE)
- HIP \$0.00** **Harvest Information Program Registration:** Registration required by the USFWS in order to hunt any migratory game bird in Arkansas. Registration is unique to the state and is required no matter how many other state registrations are possessed. Must have a Resident license: **(RS) or (HNT)**, and if hunting waterfowl an **Arkansas Resident Waterfowl Stamp (DSR)** and a **Federal Duck Stamp (DFS)**. **Expires on June 30th.**
