Dear Chairman *Last Name*:

The U.S. Fish and Wildlife Service (Service) requests a government-to-government consultation under Executive Order 17135 and Secretarial Order 3206 to discuss its intent to prepare an Environmental Impact Statement (EIS) on the Great Plains Wind Energy Habitat Conservation Plan (HCP). The planning area for this effort includes Tribal lands which may be considered for locations to establish wind energy facilities, species mitigation sites, or be avoided. Actual use of Tribal lands will be based upon future arrangements between your Tribe and the wind energy companies participating in this planning effort. The HCP will not likely cover specific project sites at this time, rather it will address the potential for their future development across the planning area. We must include environmental effects to Tribal lands in our EIS analysis; thus, we welcome your input on concerns or information relevant to the proposed HCP on both Tribal and aboriginal lands.

The HCP is being developed by the Wind Energy Whooping Crane Action Group, hereafter referred to as the Proponent. The goal of the Great Plains Wind Energy HCP is to develop a consistent, systematic, and predictable approach for wind energy development while ensuring the conservation of certain species. The Service has been working with the applicant on the preparation of the HCP, but a draft of this document is still in progress.

The objective of the EIS is to evaluate the potential impacts that would result from the Great Plains Wind Energy HCP and an associated Incidental Take Permit (ITP). Under the Proposed Action, the Service would issue an ITP to the applicant under the provisions of Section 10 of the Endangered Species Act of 1973, as amended. The Great Plains Wind Energy HCP and potential ITP covers construction, operation, and maintenance associated with multiple commercial, wind energy facilities within all or portions of North Dakota, South Dakota, Montana, Colorado, Nebraska, Kansas, New Mexico, Oklahoma, and Texas.

Species being considered for inclusion in the Great Plains Wind Energy HCP by the Proponent include certain species listed as federally threatened or endangered, or having the potential to become listed during the life of the HCP, and having some likelihood of being taken by the Proponent's activities within the proposed permit area. Species currently considered for take coverage include the whooping crane (*Grus americana*), endangered; interior least tern (*Sterna antillarum athalassos*), endangered; piping plover (*Charadrius melodus*), endangered; and lesser prairie-chicken (*Tympanuchus pallidicinctus*), candidate.

The permit area for the Great Plains Wind Energy HCP is defined as the non-Federal lands within the 200-mile wide corridor determined by defining the center line of the whooping crane migration observations and extending that line by 100 miles on either side, between the Gulf Coast of Texas north to the Canadian border. In addition, the permit area includes the non-Federal lands within the range of the lesser prairie-chicken, with the boundary extending into parts of Kansas, Colorado, Oklahoma, New Mexico, and Texas (refer to enclosed Permit Area Map). In total, approximately 268 million acres and 470 counties in 9 States are located within the permit area. The ITP would cover anticipated incidental take of covered species that may result from the Proponent's covered activities you have approved on your lands that occur within this area.

In addition to consultation, the Service requests your assistance in identifying Tribal cultural and spiritual sites and interests in the planning area for the HCP in accordance with the National Historic Preservation Act to ensure that these sites and interests are taken into account and protected during project planning.

The Service is in the first stage of preparing a draft of the EIS and has opened the public scoping period (see enclosed Federal Register notice). There will be a series of agency and public informational meetings across the nine-state planning area. The agency meetings will be held in a round-table discussion format, while the public scoping meetings will be held in an open-house format. We invite you to attend the agency meetings to be held before the public meetings; however, to fully meet the intent of government-to-government consultation, the Service will be happy to meet with the Tribe individually. You are welcome to attend the public scoping meetings as well. We have enclosed a list of all agency and public meeting locations and dates.

The Service is not taking formal comments at the public scoping meetings, but we will make note of any issues raised and will accept written comment during the 90-day scoping period, ending on October 12, 2011. However, for the government-to-government consultation with your Tribe, we will accept comments throughout the process of preparing the draft EIS and draft HCP. However, we recommend your Tribe provide its comments during the 90-day scoping period so they can be adequately addressed in the planning process. We will continue this consultation throughout the finalization of the EIS and HCP, which is expected in December 2012.

Thank you for your review of this request and invitation. The Service appreciates any information you can provide, and we look forward to working with you on this project.
