**Abstract.** The abstract as well as the body of the manuscript should be in 12 point Times Roman, single column and the abstract should be single spaced with 1.5-inch margins. **Your manuscript should be submitted electronically (preferred) or on a disk (floppy zip disk or on a CD).** The title of the file should be your last name and abbreviation of state, province or country, such as **Barnhisel-KY**. If there are multiple papers, follow the location with -1, -2, etc. All papers will be converted to “.pdf” files and placed on a CD. We will use the latest available version of Adobe software and Acrobat Reader, as well as an Auto-run file will be placed on each CD. All manuscripts must be submitted using either **Word or WordPerfect**. In the case of **Poster Papers**, you may submit a written paper for review or the one or two-page extended abstracts should be submitted as **Word or WordPerfect** documents on disks. These “written poster papers” will be placed on the CD, or you may submit the poster paper as a **Power Point Presentation**. These disks or electronic files will be accumulated for placement on a CD and hard copies of the Proceedings will not be available.

A hard copy of the manuscript is not needed as OSM will print two copies of your electronic copy for the review process. The final copy of the manuscript should also be submitted electronically, however, the local editor has the prerogative to make editorial adjustments that will not be reviewed by the authors when the manuscript does not comply with the format given in this document. **It is therefore essential that the instructions listed below be followed explicitly.** The pages of instructions have been typed in the format you are requested to follow. The abstract should be limited to 350 words (this abstract has 357 words). Note that the margins of the abstract are indented 1.5” as opposed to 1’ margins for the text. **The abstract with the footnotes must fit on one page.**

Additional Key Words: proceedings, instructions. (Note: key words **are in addition** to those appearing in the title.)

Doe is Assistant Professor of English, Syracuse University, Syracuse NY 13210. **Do not use** multiple superscripts (e.g. 3, 4) for additional authors, but list them as separate paragraphs under the first author. Shortened addresses may be used when the additional authors are at the same location.
