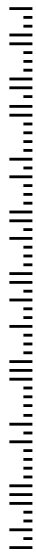

Other Important Information About Our School

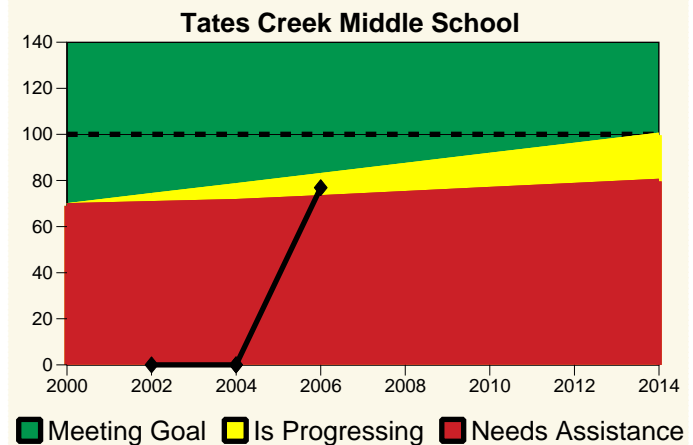
State Contest Results: Our 7th/8th grade band received all Proficients at the KMEA Festival and several students received individual and ensemble awards. Our band also received 2nd place in Music in the Parks. The TCMS orchestra received all Proficient at the KMEA Festival. TCMS had students present their science fair projects at the regional science fair.

Extracurricular Activities: Beta Club, Student Council, Dance Team, STLP, Speech, Academic, and Math Teams, Yearbook Staff, Football, Boys and Girls Basketball, Boys and Girls Track, Cheerleading, Girls Volleyball, Foreign Language Club, Intramurals, Jazz Band, and Step Team. Titan University, our after school program, offers many activities such as guitar, aerobics, etc.

Awards & Recognitions: We were very honored to have a group of students win the Ecybermission Regional Criteria Award for Creativity and Innovation. TCMS also had great success in our athletic programs. We were runner-up in The City Tournament for Boys Basketball City Champions for football and our girls won bracket 2 in the KBA Volleyball Invitational Tournament.

What We are Doing to Improve: Our vision of TCMS is to incorporate an engaging and rigorous curriculum that will teach students to think and provide depth in all academic areas. The school will be applying for the middle years program with the International Baccalaureate Organization. We have begun our extensive staff training of best practices to increase student achievement and continue to improve a positive school climate and culture.

How We Are Doing

Kentucky uses the Commonwealth Accountability Testing System (CATS) to hold schools accountable for student progress. CATS has three parts: the Kentucky Core Content Tests, readiness tests by grade level, and other measures of the school's performance,

including attendance, retention and dropout rates. Together these three elements make up a school's CATS Performance Score for every two-year period. The goal is that by 2014 nearly all students will score proficient or distinguished.

Kentucky Core Content Tests:

Kentucky's tests rate student performance as either Novice, Apprentice, Proficient, or Distinguished. These categories translate into a scale of 0-140, with 100 being considered proficient. This chart compares our school's performance with all the schools in our district and all the schools in Kentucky.

How We Use Technology to Teach: Our teachers incorporate technology in their classes as it relates to the content and to enhance their lessons.
