Instructions for Nonresident Alien Land Registration

Individuals

Pursuant to Ohio Revised Code section 5301.254(B), "every nonresident alien who acquires an interest either in his own name or in the name of another, in real property located in this state that is in excess of three acres or that has a market value greater than one hundred thousand dollars or any interest in minerals, and any mining or other rights appurtenant thereto or in connection therewith that has a market value in excess of fifty thousand dollars, shall, within thirty days of the acquisition of the interest in the property" is required to file this form.

Business Entities

Pursuant to Ohio Revised Code section 5301.254(C), "every corporation or other business entity that is created or organized under the laws of any state or a foreign nation or that has its principal place of business in a foreign nation, in which a nonresident alien acquires at least ten per cent of the shares of stock or other interests or in which any number of nonresident aliens acquire at least forty per cent of the shares of stock or other interests, and which acquires any interest either in its own name or in the name of another, in real property located in this state that is in excess of three acres or that has a market value greater than one hundred thousand dollars or any interest in and to minerals, and any mining or other rights appurtenant thereto or exercisable in connection therewith that has a market value in excess of fifty thousand dollars shall, within thirty days of acquisition of the interest in the property" is required to file this form.

Changes

Ohio Revised Code section 5301.254(D) requires business entities to notify the secretary of state within thirty days of any changes that render a previously filed Nonresident Alien Land Registration form to become inaccurate.

An individual who previously filed a Nonresident Alien Land Registration form is required to notify the secretary of state if he/she becomes a resident alien or a citizen of the United States.

An individual or business entity who previously filed a Nonresident Alien Land Registration form is required to notify the secretary of state upon the sale of the previously reported real property or mineral or mining rights.
